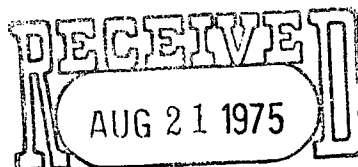

Gentlemen:

Continental Oil Company's application for a 40-acre NSP unit for the State KT-24 No. 1 well located in the NW/4 of SE/4 of Section 24, T-21S, R-35E, and a 40-acre non-standard proration unit for the State KT-24 No. 2 well located in the SW/4 of SE/4 of Section 24, T-21S, R-35E.

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5(C) of the Special Rules and Regulations for the Eumont Gas Pool (Order No. R-1670) for approval of a 40 acre non-standard gas proration unit for its State KT-24 No. 1 well and a 40 acre non-standard gas proration unit for its State KT-24 No. 2 well. The proposed unit for the State KT-24 No. 1 well to consist of the NW/4 of SE/4 of Section 24, T-21S, R-35E. ~~The proposed unit for the State KT-24 No. 2 well to consist of SW/4 of SE/4 of Section 24, T-21S, R-35E.~~

State KT-24 No. 1 well currently has an 80 acre non-standard gas proration unit assigned as approved by NSP order No. 818. We wish to have this order dated November 25, 1969 cancelled as it refers to No. 1 well.

~~The State KT-24 No. 2 well was recently restored to production. This well was a shut-in oil well. Current production is 1 Barrel of oil per day and 110 MCF of gas per day.~~

In support of this request, we would like to point out that the proposed unit conforms with the requirements of Rule 5 (b) in all respects as follows:

- 1) Said Unit consists of contiguous quarter/quarter sections and/or lots
- 2) Said Unit lies wholly within a single governmental section
- 3) The entire proposed unit may be reasonably presumed to be productive of gas
- 4) The length or width of said unit does not exceed 5280'
- 5) Copies of this application have been furnished by certified mail to all offset operators and all operators within Section 24
