Skelly Oil Company, operator of the Baker "C" Well No. 1, Blinebry Pool, located in the center of the NE/4 of the NE/4 of Section 26, T22S, R37E, Lea County, New Mexico, respectfully requests administrative approval of an 120 acre non-standard gas unit for this tract. This well is currently producing as an oil well in the Blinebry oil pool. Due to the increase in the gas-oil ratio, Baker "C" Well No. 1 is being reclassified as a gas well in the Blinebry gas pool as of July 1, 1970, with 40 acres allocated to the gas unit. The Baker "C" lease, comprising the N/2 NE/4 and SW/4 NE/4 of Section 26, T22S, R37E, Lea County, New Mexico, contains 120 acres and the Baker "C" Well No. 1 is the only well on the lease producing from the Blinebry Pool.

All offset Blinebry Pool operators to the proposed non-standard gas unit are being advised by copy of this application of this proposal.

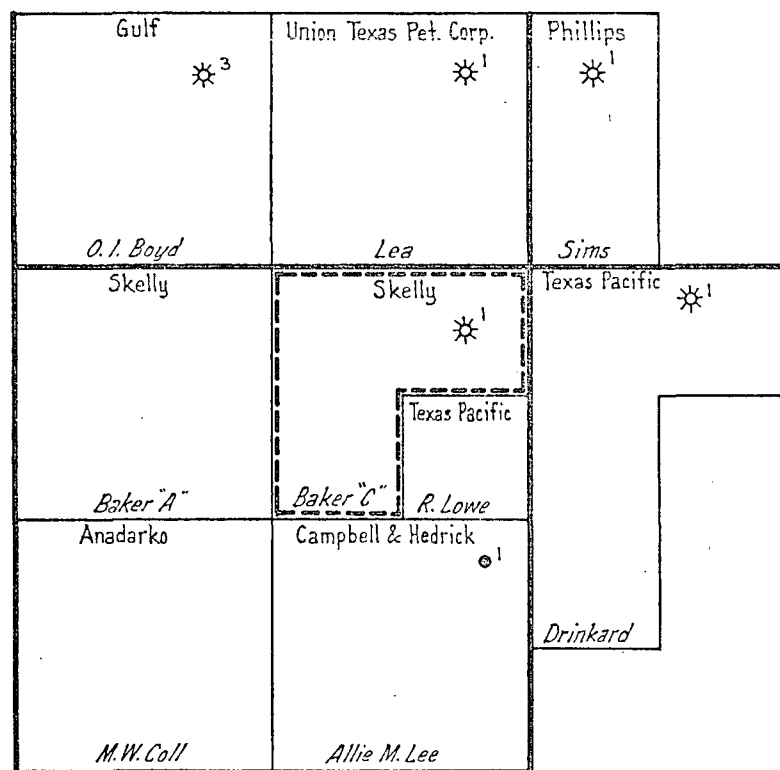
