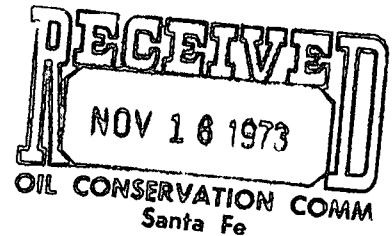

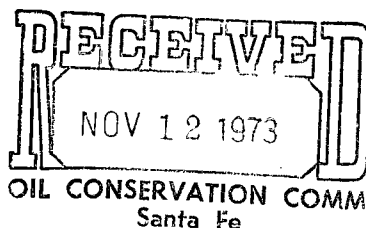

Gentlemen:

Effective October 1, 1973, Amoco Production Company's State "EK" Well No. 4, located in Unit E, Section 25, T-14-S, R-29-E, Chaves County, New Mexico was reclassified from an oil to a gas well. This reclassification necessitates the formation of a non-standard proration unit.

~~NSP-846~~ NSP-846 dated October 1, 1971, authorized the formation of a 120-acre non-standard gas proration unit and dedicated to our State "EK" Well No. 1. The acreage consists of the W/2 SW/2 & SE/4 SW/4 Section 24, T-14-S, R-29-E, Chaves County, New Mexico.

In accordance with the provisions of the Double "L" Queen Associated Pool rules, Amoco Production Company submits this request for an exception to Rule 2, under Rule 3, for the formation of a 160-acre non-standard gas proration unit comprising the SE/4 NW/4, W/2 SW/4, and the SE/4 SW/4 of Section 25, T-14-S, R-29-E, NMPM, Chaves County, New Mexico. This unit shall be jointly assigned to our State "EK" Well No. 1 located in Unit N, and State "EK" Well No. 4 located in Unit E of Section 25, as provided in Rule 7.

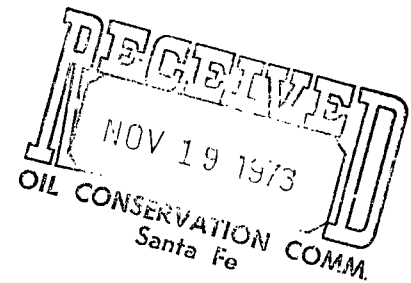


