Dear Mr. Conder:

The New Mexico Oil Conservation Division (OCD) has received Rice Operating Company's report and request to close the above-referenced site (dated December 12, 2008). The report is acceptable to the OCD. However, the material used to plug the groundwater monitoring wells must be a cement grout with 1% to 3% bentonite. Please submit to the OCD a final plugging report within one year of receipt of this notice.

The above-referenced report, submitted in accordance with 19.15.29 NMAC (Part 29; formally, Rule 116), indicates that Rice Operating Company has met the requirements of 19.15.29 NMAC; therefore, the OCD approves the report and hereby notifies you that the remediation plan (1R-427-62) is terminated in accordance with 19.15.29 NMAC.

Please be advised that OCD approval of this report does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the owner/operator of responsibility for compliance with any OCD, federal, state, or local laws and/or regulations.

Dear Mr. Conder:

The New Mexico Oil Conservation Division (OCD) has received Rice Operating Company's report and request to close the above-referenced site (dated December 12, 2008). Since the site has been remediated in a timely matter and there is no evidence of groundwater contamination, the OCD hereby rescinds the requirement for submittal of an abatement plan under 19.15.30 NMAC (Part 30; formally, Rule 19). Also, since the site has been remediated, the termination of the remediation plan (1R-427-62) will be approved in accordance with 19.15.29 NMAC (Part 29; formally, Rule 116) (under separate cover).

Please be advised that OCD approval of this rescindment does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the owner/operator of responsibility for compliance with any OCD, federal, state, or local laws and/or regulations.
