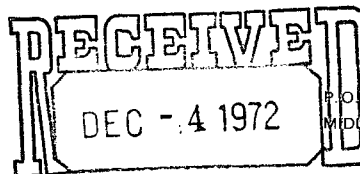

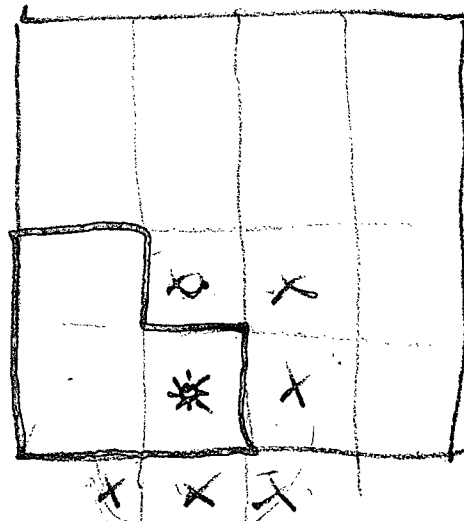
Mobil Oil Corporation is in the process of plugging back the subject well from the Penrose-Skelly (Grayburg) Pool and recompleting it as a gas well in the undesignated (Eumont) gas pool.

This well is located in Unit N, 660 ft from the south line and 1980 ft from the west line of Sec. 28, T21S, R37E, Lea County, New Mexico. Mobil's E. O. Carson lease contains 320 acres of land, 120 acres of which is in said Sec. 28. It is Mobil's desire to assign this 120 acres, described as the W1/2 of SW1/4 and SE1/4 of SW1/4, Sec. 28, T21S, R37E, Lea County, New Mexico, as a non-standard gas proration unit to E. O. Carson Well #4.

It is respectfully requested that this application be approved by administrative action. If the Commission concludes that this matter cannot be disposed of administratively, please set it for hearing. *pk*
