



Atlantic Richfield respectfully requests administrative approval under the provisions of Order No. R-1670, Rule 29, for a 40-acre non-standard Blinbry Gas proration unit for the S. J. Sarkeys No. 4 well, located 330' FSL and 990' FEL, Sec. 23, T-21S, R-37E, in Lea County, New Mexico. The proposed proration unit will comprise the SE/4, SE/4 of Sec. 23, as shown on the attached plat.

The S. J. Sarkeys No. 4 is currently classified as an oil well in the Blinbry Oil Pool. Effective January 1, 1973, it will be reclassified under R-1670, Rules 27 and 28, to Blinbry Gas, because of a high gas-oil ratio. The well is awaiting connection to the El Paso gathering system and assignment of a gas allowable.


