

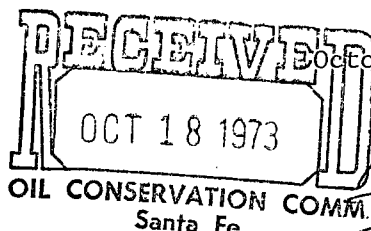

Dear Mr. Ramey:

It is respectfully requested that a non-standard, 40-acre unit, comprising the NW/4 of the NW/4, Section 24, T-9-S, R-37-E, be assigned to the subject well.

The well was completed on January 4, 1973, with a potential of 9 barrels of oil, 167 MCF of gas, and gas-oil ratio of 18,555 cubic feet per barrel. The well was classified as an oil well and assigned to the Sawyer San Andres Field.

Effective September 1, 1973, the well was reclassified as a gas well under the special rules of the Sawyer San Andres Pool. This was based on a gas-oil ratio test taken on 3-26-73, in which the well produced 4.1 barrels of oil, 155.4 MCF of gas, and gas-oil ratio of 37,902 cubic feet per barrel.

Form C-102 is attached in duplicate, outlining the 40-acre tract to be assigned to the well.

Copies of this request are being sent to J. M. Huber Corporation and Union Texas Petroleum, as offset lease owners, by certified mail.
