

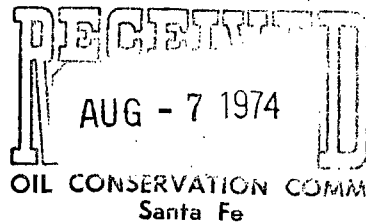

Continental Oil Company's Application for a 240-acre NSP Unit - SEMU Eumont No. 68 - Section 23, T-20S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (b) of the Special Rules and Regulations for the Eumont Gas Pool of Order No. R-1670 for approval of a 240-acre Non-Standard Gas Proration Unit for its SEMU Eumont No. 68, located 1980' FSL 1980' FEL of Section 23, T-20S, R-37E, Lea County, New Mexico in the Eumont Gas Pool. The Unit is proposed to consist of SE/4 and the E/2 of the SW/4 of Section 23, T-20S, R-37E.

SEMU Eumont No. 68 currently has a 640-acre Non-Standard Gas Proration Unit assigned, as approved by Order No. R-3833. We wish to have this order cancelled, as it refers to well No. 68 in paragraph 1 (f) of the Order dated September 8, 1969.

In support of this request, we would like to point out that the proposed unit conforms with the requirements of Rule 5 (b) in all respects as follows:


- 1) Said Unit consists of contiguous quarter/quarter sections and/or lots
- 2) Said unit lies wholly within a single governmental section
- 3) The entire proposed unit may be reasonably presumed to be productive of gas
- 4) The length or width of said unit does not exceed 5280'

A plat is attached hereto, showing to the best of our knowledge and belief, the proposed unit, the location of the well, and the offset

ownership. The proposed unit lies inside the Southeast Monument Unit, therefore, Continental Oil Company is the only offset operator and the only operator within said unit. Therefore, we respectfully request that this application be handled as soon as possible.

In view of the facts set out herein, it is respectfully requested that the Commission enter an order approving the Non-Standard Gas Proration Unit for Continental Oil Company's SEMU Eumont No. 68.



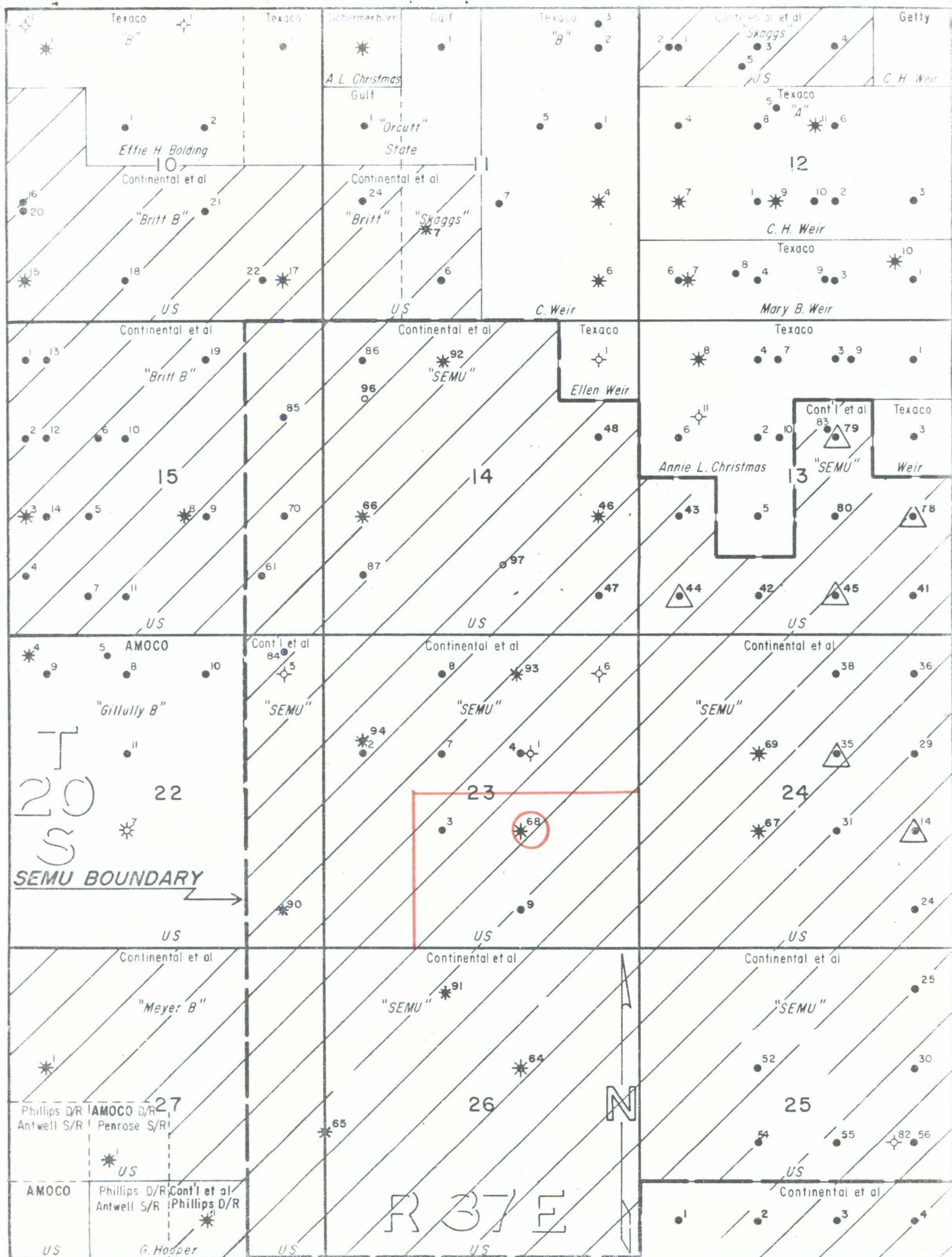
