The New Mexico Oil Conservation Division (OCD) recently completed an OCD Discharge Permit (7/1/2009) for a geothermal power plant southwest of Lordsburg, New Mexico and just north of Cotton City, New Mexico within the Animas Valley.

The OCD conducted two public hearings in Lordsburg, New Mexico. Subsequent to the hearings, the OCD finalized a discharge permit for Raser Technologies (Los Lobos) on July 1, 2009 and posted it on its Internet. Any final public comments were to be submitted directly to the WQCC requesting a hearing under the WQCC.

I am writing to determine whether public comments or appeals were received by the WQCC for this project and whether there is a hearing scheduled before the WQCC in the event that the above occurred.
