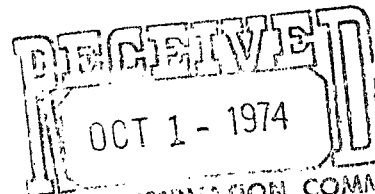

Gulf Oil Corporation requests your administrative approval for a 80 acre non-standard proration unit in the Blinebry Gas Pool consisting of the E/2, NE/4, Section 16, 21-S, 37-E, Lea County, New Mexico, to be dedicated to our Harry Leonard (NCT-E) well No. 4, located 660' FN & EL, Section 16, 21-S, 37-E.

In support of this application the following facts are submitted.

1. Our Harry Leonard (NCT-E) lease is described as the NE/4, Section 16, 21-S, 37-E. Well No. 1, located 1980' FN & EL, well No. 2, located 1980' FNL & 660' FEL and well No. 3, located 660' FNL & 1980' FEL, all in Section 16, 21-S, 37-E and all three wells are producing from the Blinebry oil zone.
2. Subject well was recently reclassified as a Blinebry gas well due to Gas-Oil Ratio in excess of 50,000/1, necessitating this non-standard unit.
3. Well No. 2 is presently producing approximately 1 BOPD and will be shut in upon approval of this application.
4. There are no other wells producing from the Blinebry zone in the NE/4 NE/4, Section 16, 21-S, 37-E.
5. The attached plat shows the proposed 80 acre non-standard unit outlined in red.
6. All offset operators have been furnished a copy of this application.

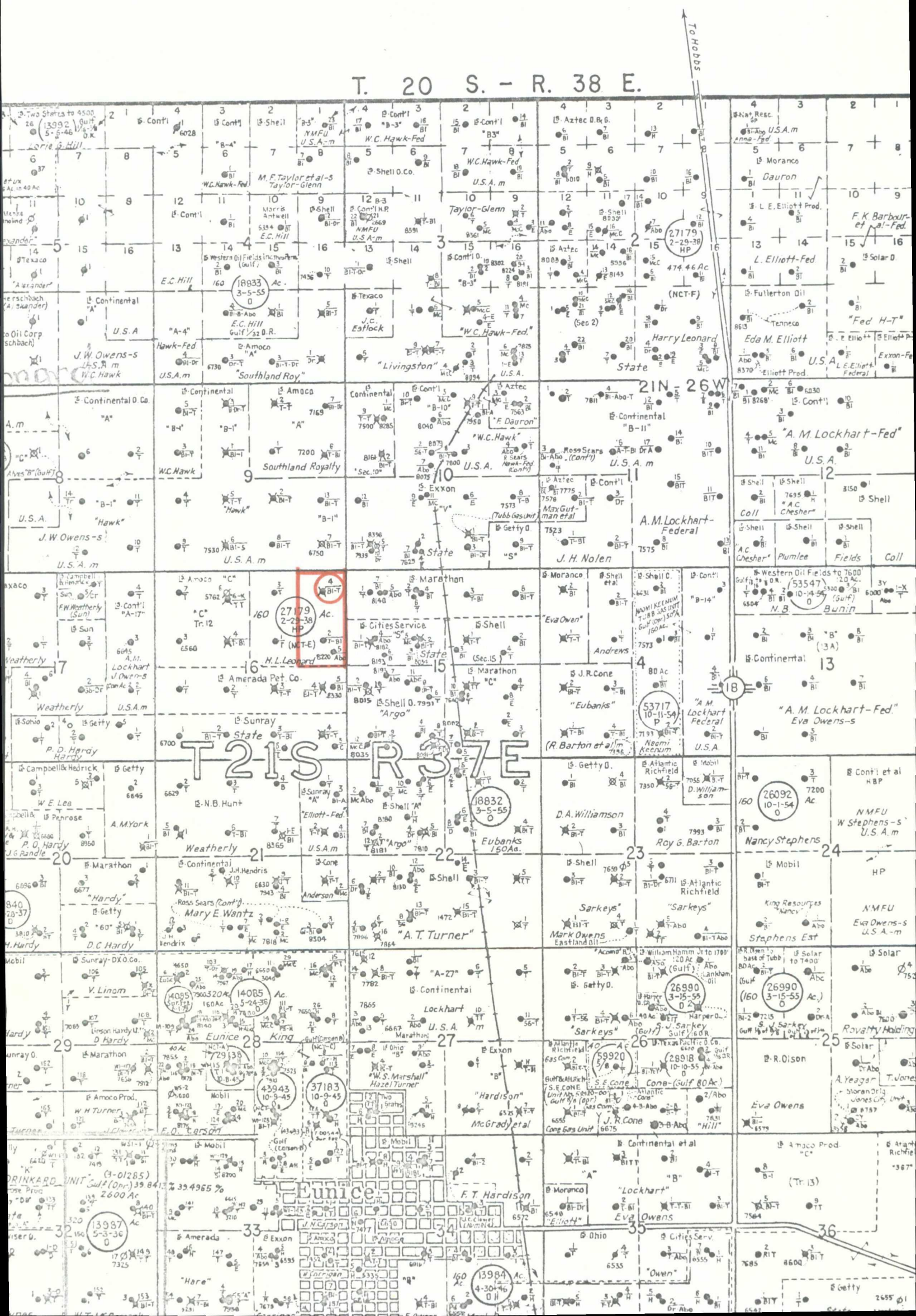

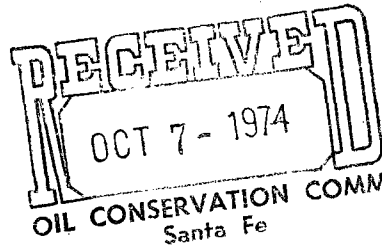
