<u>Due to the diverse ownership between the Thyme "APY" Federal and the Coriander "AOC" State Leases, production from each of the leases shall be separately metered prior to commingling.</u>

The commingled production shall be stored at the Thyme "APY" Federal tank battery located in Unit B of Section 1, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico.

It is the responsibility of the producer to notify the transporter of this commingling authority. The operator shall notify the Hobbs district office of the Division upon commencement of commingling operations.
