The New Mexico Oil Conservation Division (OCD) has received the proposed Addendum to the Stage 1 and Stage 2 Abatement Plan for the Rice Operating Company's (ROC) BD SWD Jct F-17 Site, dated July 27, 2010, and has conducted a review of the Addendum. The Addendum, submitted for the above-referenced site, indicates that ROC has substantially met the requirements of Part 30 (formerly, Rule 19) for a Stage 1 and Stage 2 Abatement Plan. Therefore, the OCD hereby conditionally approves the Addendum to the Stage 1 and Stage 2 Abatement Plan (AP-47) for the above-referenced site, in accordance with 19.15.30.16 NMAC:

ROC must place the liner at least 1 foot to the southeast of the "15' South" boring.
