

Describe Cause of Problem and Remedial Action Taken.\*

Tank struck by lightning, exploded and released above stated liquids. Remediation efforts completed as follows. Soil samples and tests were gathered and analyzed from the site. The results were discussed with NMOCD personnel(Leking), and the following work plan was approved. A 6" excavation of the affected site with soils to be removed and placed at an approved disposal facility for storage. The excavated area was then to be backfilled with like clean soils. This site is closed.
