Lisa Rice, Kevin Wilson:

As we discussed, OCD is requiring I & W to submit a contingency plan for its brine well in Carlsbad by close of business on Friday, November 7, 2008 to both the Eddy County Emergency Management Service and to OCD. The contingency plan should include the following:

1) Contact list with phone numbers and email addresses for all organizations that I & W would need to contact if it were to detect subsidence or collapse at its brine well, including the Eddy County EMS, State Police, Carlsbad Police and Fire Departments, OCD District II office in Artesia and OCD Santa Fe office, etc.

2) Daily surveillance plan, including a log, that records I & W's daily inspections of the brine well and vicinity.

3) Weekly monitoring plan, including a log, that records I & W's weekly survey of its survey points.

4) Action plan for decommission the brine well by disconnecting all power, plumbing, and supply and production pipelines, etc. so that if a collapse occurs, the damage to surrounding infrastructure is minimized.

The intent of these additional requirements is so that if a collapse occurs, I & W will already have gone the process of preparing lists for contacting the appropriate organizations and plans for monitoring the brine well.

Glenn -

I just landed in Charlotte. Please forgive this late reply. As to urgency, it's difficult to gauge without more information. Please forward anything available and I will give you my opinion. Much of my initial response has simply to do with the cavern's size and depth. I think another important factor would be the length of time, and percent of production, since the early 80's change in mining mode, (direct to reverse).

It should be clear, there are professionals far more qualified than I, to consult OCD on the risk of collapse. I am happy to help in any way possible, but a much better assessment can be made by either of those gentlemen referred to you in my previous email. Nonetheless, I would like to review the history, particularly as it compares to the other problem wells.

Hello folks - some quick thoughts and recommendations on the Carlsbad brine well.

- Emergency response/contingency plan involving State/County/City
- Every attempt should be made to characterize the cavern
  - o Well construction
  - o Production history
  - o Estimated dimensions
  - Local/regional geology, (stratigraphy and structure)
  - Stability model Geomechanical study by Respec or PB-ESS, (Dr. Van Sambeek and Dr. Ratigan, respectively)
    - o Given cavern's sensitive location, several steps might be considered
      - High resolution seismic survey
      - Subsidence monitoring
      - Re-entry for direct monitoring
        - Seismic probe
        - Pressure probe
        - Well and cavern logging
        - If risk is found intolerable, develop concepts for possible backfilling
          - Sand
          - Crushed limestone
          - Salt from potash mine
          - If backfilling or other stabilization methods are prohibitive, consider ultimate failure with marginal impact

- Reroute roadways and utilities
- Reroute irrigation canal
- Relocate homeowners and businesses

Here is a synopsis regarding I&W's brine operation in Carlsbad; BW-6:

Depth to ground water in this area is about 50 ft bgs.

The first well, Eugenie #1 (see attached aerial photo), was installed using a cable tool rig in August of 1978. The depth to salt (top of Salado) is 456 ft bgs where the casing was set. The tubing was set at a depth of 574 ft. Fresh drinking water from the city introduced down the annulus and brine produced up the tubing. During 1979, brine produced at a rate of just over 600 bbl/day. The production was insufficient for their needs so a second well, Eugenie #2, was installed by cable tool 325 ft NW of the first well in late-November of 1979. The casing on this well was set to only 285 ft (top of Rustler) with tubing down to a depth of 583 feet. The salt was fractured between the two wells and fresh water was introduced down the tubing of Eugenie #2 and brine produced from the tubing in Eugenie #1. During 1980 brine was sold at an average rate of more than 1,200 bbl/day. From January thru September of 1981 the rate of brine production was nearly 1,700 bbl/day.

The facility was first permitted by the OCD on December 18, 1982 (GWB-5) operated by Permian Brine Sales & Service based in Odessa. B&E, Inc. of Hobbs owned the land and took over operations in July 1983, with Permian still a minority partner. EID took over regulatory responsibility in September 1983 and the permit renewed by EID in 1987 as DP-323. OCD regains oversight in June 1989. During first six months of 1989 average brine production is about 400 bbl/day.

Ownership transfers to I&W in July 1995. April 1996 discharge permit renewal requires subsidence monitoring on regular basis. No reporting of subsidence monitoring exists in our files. During 1995-1996, OCD repeatedly tries to schedule integrity testing and cavern survey without success and orders I&W to cease brine production on October 11, 1996. This finally gets their attention as sonar survey of extraction well, Eugenie #1, completed on October 19, 1996. Cavern roof appears to be 135 ft across and 45 ft high (452 to 497 ft bgs) w/ capacity of 31,000 bbls. System goes back into service thereafter. Sonar profile shows highly symmetric conical cavern, which would not make sense given the mode of operation (i.e. 2-well system). This might be explained by the lack of a complete survey as the bottom of sonar log is perhaps 75 feet above the full tubing depth.

During cavern pressure testing in November 1999, injection well shows brine leakage at surface and NOV is issued. Eugenie #2 is plugged per OCD direction in January 2000. OCD tells I&W to install 3 monitoring wells to check for groundwater contamination. I&W installs 2 wells in March 2000, testing shows no indications of chloride contamination. I&W returns to single-well brine production using only Eugenie #1 after retesting in June 2000.

Renewal application of January 29, 2001 states brine production at only 200 bbl/day, though average daily production for the prior quarter is 647 bbl/day. Ramps up to 1,650 bbl/day by 2<sup>nd</sup> quarter of 2006.

Sonar log run August 2007 from 435 to 474 ft bgs (again, only scanned the uppermost portions of the cavern). Maximum diameter of 158 ft and volume of 48,000 bbls.

Jim's Water Service brine well collapse occurs on July 16, 2008. Eugenie #2 shut in on July 22<sup>nd</sup>, then plugged on October 1, 2008. OCD requests contingency plan by November 7, 2008 which would include daily surveillance and weekly monitoring but no such plan from I&W is in our files. When speaking with Dave Harrell of BLM late last week, he mentioned something having being submitted to Eddy County by I&W, but his recollection of Joel Arnwine's review of that document said it left a whole lot to be desired.

The diagram (attached) for subsidence monitoring provided by I&W in May of 2007 indicates 3 benchmarks, 2 of which are too far away from brine well. A graph of quarterly fresh water injection and brine production is also attached. Between 1989 and the end of the first quarter of 2007, the facility reports production of 2,874,230 bbls of brine while injecting only 1,868,115 bbls of fresh water. If accurate, this would mean that the brine solution was 35% salt by volume and the cavern would have grown by just over one million barrels over that time (21 times larger than surveyed).

# Introduction:

The Oil Conservation Division hereby establishes a ½ mile Area of Review (AOR) for all APDs surrounding the existing brine wells at the I & W, Inc. facility (BW-006). Well No. 1 was constructed with 9 5/8" casing set to 350 ft. bgl. The well was drilled to 663 ft. (see Table 2) and 7" casing was set at 456 ft. bgl. Tubing was set at a depth of about 601 ft. bgl before plug and abandonment.

Well No. 2 was constructed with 5  $\frac{1}{2}$ " casing set at 285 ft. bgl. Tubing consisted of 2 7/8" tubing, which was perfed at 335 ft. bgl.

# **Owner/Operator Actions:**

I & W Inc. voluntarily and permanently shut-in the brine well on July 22, 2008. The well was later plugged and abandoned on October 31, 2008. These actions were undertaken after the Jims Water Service (BW-005) brine well collapse on July 16, 2008 as a precautionary measure by the owner/operator. Due to its shallow depth and location in the City of Carlsbad, the brine well cavern is in close proximity to many infrastructure features, e.g., roads, railroads; irrigation canal, etc. (see Figures 2 & 3).

# Internal APD AOR (1/2 mile) Policy:

More recently, the Loco Hills Brine Well No. 1 (BW-21) just north of Loco Hills, New Mexico collapsed in November of 2008. Brine Well No. 1 was plugged and abandoned on 7/7/2008. The collapse may have been caused by the drilling of a well that took on water at a similar depth interval and suspected by the OCD of being hydrogeologically connected with the salt cavern at Brine Well No. 1. Consequently, the collapse at Brine Well No. 1 may have been caused by the dewatering and/or loss of pressure in the cavern, which resulted in the destabilization of the ground around Brine Well No. 1. To avoid this in the future from occurring at this facility (BW-6), the OCD has developed an Internal Application Permit to Drill (APD) Area-of-Review (1/2 Mile) Staff Policy (see Figure 4).

# Eddy County Emergency Response Plan:

Ground water most likely to be affected by a spill, leak, or accidental discharge to the surface is at a depth of approximately 45 feet with a TDS of approximately 200 mg/L. The brine well discharge permit addresses well construction, operation, monitoring of the well, associated surface facilities, and provides a contingency plan in the event of accidental spills, leaks and other accidental discharges in order to protect fresh water. However, the discharge permit does not address a catastrophic collapse scenario. The OCD is currently working with I & W Inc. to complete a Contingency Plan in addition to working with the Eddy County Hazmat, State Police and the Local Emergency Planning Committee (LEPC- Fire Marshal). OCD will require I & W, Inc. to submit a copy of its final Contingency Plan to the Eddy County Hazmat responders. In addition, the OCD will recommend to Eddy County that it's Emergency Plan include a scenario for a

potential brine well collapse scenario from this facility in the interest of public health and safety.

OCD District 2 shall contact the Environmental Bureau whenever it receives any APDs located within a ½ mile Area-of-Review (AOR) from the brine wells at this facility (see Figures 4 - 6). District Office 2 staff and/or the District Supervisor shall make the preliminary determination and internally discuss the determination for approval and/or denial jointly with the Environmental Bureau Staff and/or Bureau Chief to reach consensus on a final determination.

As we discussed, OCD is requiring I & W to submit a contingency plan for its brine well in Carlsbad by close of business on Friday, November 7, 2008 to both the Eddy County Emergency Management Service and to OCD. The contingency plan should include the following:

1) Contact list with phone numbers and email addresses for all organizations that I & W would need to contact if it were to detect subsidence or collapse at its brine well, including the Eddy County EMS, State Police, Carlsbad Police and Fire Departments, OCD District II office in Artesia and OCD Santa Fe office, etc.

2) Daily surveillance plan, including a log, that records I & Ws daily inspections of the brine well and vicinity.

3) Weekly monitoring plan, including a log, that records I & W's weekly survey of its survey points.

4) Action plan for decommission the brine well by disconnecting all power, plumbing, and supply and

production pipelines, etc. so that if a collapse occurs, the damage to surrounding infrastructure is minimized.

The intent of these additional requirements is so that if a collapse occurs, I & W will already have gone the process of preparing lists for contacting the appropriate organizations and plans for monitoring the brine well.

Pusher or supervisor in charge will proceed immediately to the accident scene to assist emergency services in locating the injured person and transporting them in a timely manner. The pusher or supervisor will call on other supervisors or personnel to assist as he sees fit for the circumstances.

The Safety Department, depending on the nature of the injury will either proceed to assist at the accident scene or proceed to the emergency room for the arrival of the injured. The Safety Department will assist in notification, in person, if possible, of the family of the injured. The Safety Department will also assist the family with their immediate needs.

The Operations Manager and the Logistics Manager will immediately proceed to the accident scene with the priority of ensuring the injured individual or individuals are properly on their way to medical treatment. When this is accomplished, they will secure the accident scene and begin the preliminary investigation.

The General Manager will immediately proceed to the proper office (Loco Hills or Carlsbad) and assume overall management, including communication as needed with emergency services, law enforcement, regulatory officials, and media. All press releases or communications regarding the accident will be issued or cleared through the General Manager.
