A 3" threaded nipple on the suction side of the disposal pump started leaking and washed out. The dike area was filled up and then breached on the north side of the dike. An estimated 60 bbls of fluid composed of 40 bbls of produced water and 20 bbls of skim oil ran downhill along the electric line ROW some 2000' to the north and then where the terrain flattened turned east for 400' before coming to an end. Intermittent oil staining of the soil along the way is evident. 140 bbls of produced water was recovered from inside this dike. No freestanding fluid was found outside the dike along the spill run. Repairs to the suction line were made and soil immediately outside the dike was scraped up and the dike walls were repaired.					
Describe Area Affected and Cleanup Action Taken.*					
The dike wall will be raised, compacted and widened to prevent future releases. A sump pump and level in dike call out will be installed. Contaminated soil inside the dike will be dug out and removed to an approved disposal site. A remediation plan for the spill run area is being developed and will be submitted within 10 days and initiated when approved.
