Dear Mr. Fesmire:

Chesapeake Operating, Inc. ("Chesapeake") hereby seeks administrative approval to amend Administrative Order NSL-6172 which approved a non-standard location for the PLU Ross Ranch "19" Federal Well No. 1H at a surface location and penetration point 100 feet from the South line and 400 feet from the East line and a bottomhole location 350 feet from the North line and 400 feet from the East line of Section 19, Township 25 South, Range 30 East, NMPM, Eddy County, New Mexico.

Chesapeake has revised the surface location and penetration point for the horizontal well. As shown on the attached C-102, the surface location and penetration point will be 100 feet from the South line and 475 feet from the East line of said Section 19. The bottomhole location remains at a standard location 350 feet from the North line and 400 feet from the East line of Section 19. A 160-acre project area has been dedicated to the well consisting of the E/2 E/2 of Section 19.

This location is unorthodox because the wellbore penetrates the Bone Spring formation at a point 100 feet from the South line of Section 19 and is therefore closer than allowed by Division rules.

A copy of this application with all attachments was mailed to BEPCo., LP who is the operator of the Unit. BEPCo. was advised that if they have an objection to this application it must be filed in writing with the Division's Santa Fe office within twenty days from the date notice was sent. It was also advised that if no objections were received by the Division within twenty days, the Division Director could approve the application.
