
Administrative Order SD-89-1

Dear Ms. Wilcox:

Per your application dated May 9, 1989, Doyle Hartman is hereby authorized to simultaneously dedicate a previously approved 160-acre non-standard gas spacing and proration unit (Division Order No. R-427, dated April 16, 1954) comprising the W/2 NE/4 and the E/2 SW/4 of Section 32, Township 20 South, Range 37 East, NMPM, Eumont Gas Pool, Lea County, New Mexico, to your proposed Turner State Well No. 3, to be drilled at a standard gas well location 1980 feet from the North and West lines (Unit F) of said Section 32 and to the existing Turner State Well No. 2 located at a previously authorized unorthodox gas well location (pursuant to Rule 2(b) of the Special Rules and Regulations for the Eumont Gas Pool as promulgated by Division Order No. R-8170, as amended) 990 feet from the North line and 1650 feet from the West line (Unit C) said Section 32.

Further, you are hereby permitted to produce the allowable assigned the subject proration unit from both wells in the proportion.

Administrative Order SD-89-1-A

Dear Mr. Allred:

Reference is made to the following: (i) your application submitted to the New Mexico Oil Conservation Division ("Division") in Santa Fe, New Mexico on April 28, 2006 (*administrative application reference No. pMES0-612154771*); and (ii) the Division's records in Hobbs and Santa Fe, including the files in Division Case No. 626 and on Division Administrative Order SD-89-1: all concerning Plantation Operating, L.L.C.'s ("Plantation") plans for additional development of the Eumont Gas Pool (76480) within the existing non-standard 160-acre gas spacing unit comprising the E/2 NE/4 and W/2 NW/4 of Section 32, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico.

This application has been duly filed under the provisions of the "*Special Pool Rules for the Eumont Gas Pool*," as promulgated by Division Order No. R-8170-P, issued in Case No. 12563 on December 14, 2001.

By Division Order No. R-427, issued in Case No. 626 and dated April 16, 1954, this 160-acre non-standard gas spacing unit was initially established for Turner State Well No. 2 (*API No. 30-025-06319*) located 990 feet from the North line and 1650 feet from the West line (Unit C) of Section 32. By Administrative Order SD-89-1 dated June 5, 1989 the Division allowed the simultaneous dedication of this 160-acre unit to the Turner State Well No. 2 and to the Turner State Well No. 3 (*API No. 30-025-30613*), located at a standard infill gas well location 1980 feet from the North and West lines (Unit F) of Section 32. The Division's records indicate the Turner State Well No. 2 was plugged and abandoned in 1991.

It is the Division's understanding that Plantation now intends to drill its proposed Turner State Well No. 4 at a standard infill gas well location 660 feet from the North line and 1980 feet from the East line (Unit B) of Section 32.

By the authority granted me under the provisions of Rules 4 (B) and (D) of the special rules governing the Eumont Gas Pool, Plantation is hereby authorized to simultaneously dedicate Eumont gas production to the above described 160-acre non-standard gas spacing unit from both its Turner State Wells No. 3 and 4.


