
Amerada Hess Corporation (AHC) respectfully requests approval to drill and complete the H. W. Andrews #15 on a standard well location and simultaneously dedicate this well to the H. W. Andrews Eumont Gas Proration Unit. The required 'Application to Drill' package has been filed with the appropriate Bureau of Land Management (BLM) office in Carlsbad for approval.

The AHC H. W. Andrews lease was approved as a non-standard proration unit under order R-573 approving 240 acres consisting of the W/2 W/2 of Section 12, T-20S, R-36E and the E/2 NE/4 of Section 11, T-20S, R-36E and had dedicated thereon the H. W. Andrews #1 well located 660' FNL and 660' FWL in Section 12, Unit letter D. By Division Administrative Order NSL-3151 (SD) (September 9, 1992) the H. W. Andrews #3 was added to the GPU at a non-standard location 1980' FNL and 660' FEL of Section 11, Unit letter H. Subsequently, by Division Administrative Order NSL-3151-A (SD) (December 1, 1994), the H. W. Andrews #6 was added to the GPU at a non-standard location 660' FSL and 660' FWL of Section 12, Unit letter M.

Attached is an original 'Well Location and Acreage Dedication Plat' (NMOCD form C-102) depicting the AHC H. W. Andrews Gas Com and its' dedicated producers, a general acreage ownership plat, and a copy of the H. W. Andrews #15 'Application for Permit to Drill' (BLM form 3160-3) package with required BLM attachments (i.e. archeological survey, surface use plan, etc.) as previously filed with the BLM.

Dear Mr. Howell:

Reference is made to your application dated October 5, 1994, for an unorthodox Eumont gas well location in an existing non-standard 240-acre gas spacing and proration unit (GPU) for said Eumont Gas Pool comprising the E/2 NE/4 of Section 11 and the W/2 W/2 of Section 12, both in, Township 20 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order R-573, dated January 13, 1955 and had dedicated thereon the H. W. Andrews Well No. 1 located in Unit D of said Section 12.

By Division Administrative Order NSL-3151 (SD), dated September 9, 1992, an additional well for the subject GPU, the H. W. Andrews Well No. 3 (API No. 30-025-04211) located at an unorthodox gas well location 1980 feet from the North line and 660 feet from the East line (Unit H) of said Section 11 was approved.

It is my understanding that the subject well in this application is temporarily abandoned in the Eunice Monument Grayburg San Andres Pool and upon issuance of this order will be recompleted in the Eumont Gas Pool.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described well located at an unorthodox gas well location is hereby approved:



All provisions of said Division Administrative Order NSP-573 and NSL-3151 (SD) shall remain in full force and effect until further notice.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on December 16, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NOW, on this 13th., day of January, 1955, the Commission, a quorum being present, having considered the records and the testimony adduced at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That pursuant to the provisions of Rule 5 (a) of Order No. R-520, the Commission has authority to permit the formation of a gas proration unit consisting of other than a legal section after notice and hearing by the Commission.

(3) That the applicant, Amerada Petroleum Corporation, is the owner of oil and gas lease or leases in Lea County, New Mexico, covering the land concerned herein which comprises other than a legal section, described as follows:

TOWNSHIP 20 SOUTH, RANGE 36 EAST
E/2 NE/4 of Section 11
W/2 W/2 of Section 12

containing 240 acres more or less.

(4) That applicant, Amerada Petroleum Corporation, has a producing gas well on the aforesaid lease or leases known as Amerada Petroleum Corporation, Andrews No. 1, located 660 feet from the north line and 660 feet from the west line of Section 12, Township 20 South, Range 36 East, NMPM, Lea County, New Mexico.

(5) That said well was completed and on production prior to August 12, 1954, the effective date of Order No. R-520, and is located within the limits of the pool heretofore delineated and designated as the Eumont Gas Pool.

(6) That the royalty interest in the lease or leases covering the proposed proration unit is of common ownership.

(7) That the entire non-standard proration unit as herein proposed may be assumed to be productive of gas from the Eumont Gas Pool.

(8) That it is impractical to pool applicant's leases with adjoining acreage in the W/2 of Section 12 and the NE/4 of Section 11, Township 20 South, Range 36 East, and that there have been no objections to the formation of the proposed 240-acre non-standard proration unit.

(9) That unless a proration unit consisting of applicant's aforesaid acreage is permitted, applicant will be deprived of the full use and value of the lease or leases herein described and the well located thereon.

(10) That the creation of the proration unit herein described is in the interests of conservation and will protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of Amerada Petroleum Corporation for the approval of a non-standard proration unit in the Eumont Gas Pool be and the same is hereby approved, and a proration unit consisting of the following described acreage is hereby created:

TOWNSHIP 20 SOUTH, RANGE 36 EAST
Section 11: E/2 NE/4
Section 12: W/2 W/2

(2) That applicant's well, Amerada Petroleum Corporation, Andrews No. 1, located in the NW/4 NW/4 of Section 12, Township 20 South, Range 36 East, NMPM, shall be granted an allowable in the proportion that the above described 240-acre proration unit bears to the standard or orthodox proration unit for the Eumont Gas Pool, all until further order of the Commission.
