Chevron U.S.A. Inc. respectfully requests your approval of this administrative application for Simultaneous Dedication in the Eumont Yates 7 Rvrs Qn (Pro Gas) Pool.

Chevron has reinitiated production on the **Arnott Ramsay (NCT-D)** # 5 in the Eumont Yates 7 Rvrs Qn (Pro Oil) Pool in December of 1997. January production has indicated the well is no longer a productive oil well (average 0 BOPD). With no oil production, the well exceeds the Gas Oil Ratio limit and needs to be reclassified as a Eumont Yates 7 Rvrs Qn (Pro Gas) Pool well. Also, in the near future, it is planned to recomplete the **Arnott Ramsay** (**NCT-D**) # 5 to a higher Eumont gas interval. The Arnott Ramsay (NCT-D) # 5 will replace the Eumont Gas well, the Arnott Ramsay (NCT-D) # 14, which was plugged and abandoned in the last half of 1997 due to a severe casing failure. At this time we are requesting NMOCD approval for simultaneously dedication of the 320-acre Eumont Gas Proration Unit currently assigned to our Arnott Ramsay (NCT-D) # 3, # 14, and # 15 (Order No. NSP-607, letter dated January 16, 1979, and Order No. NSL-3193(SD)) to wells # 3, # 5, and # 15. The 320-acre gas proration unit comprises the N/2 of Section 33, T-21-S, R-36-E, Lea County, New Mexico. As the Arnott Ramsay (NCT-D) # 3, # 14, and # 15 are producing at a current combined rate of 270 MCF/D, the recompletion of Well # 5 will essentially capture reserves which otherwise would not be produced from this GPU.

Chevron respectfully requests your approval of this administrative application for Simultaneous Dedication. Attached is Order No. NSL-3193(SD), letter dated January 16, 1979, Order No. NSP-607, a vicinity map and a Form C-102 plat.
