Pursuant to NMAC 19.15.15.13, BOPCO, L.P. applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	North Indian Flats 19 Fed. Well No. 3
<u>Location:</u>	2310 feet FSL & 200 feet FEL
<u>Well unit (project area):</u>	Lot 3 (NW¼SW¼) §19-21S-29E, Eddy County, New Mexico (30.47 acres)

The well will be drilled to a depth sufficient to test the Delaware formation (undedicated). The formation is spaced on statewide rules, with 40 acre spacing, and wells to be located no closer than 330 feet to a quarter-quarter section line. A Form C-102 is attached as **Exhibit A**. The non-standard unit is due to a variation in the government survey.

The well's unorthodox surface location is due to placing it near an existing well location, which will minimize surface disturbance. **Exhibit B**. In addition, moving the well to the east and southeast places the well in an arroyo, which the BLM will not allow. **Exhibit C**.

The following leases are involved:


1. Federal Lease LC 065609, covering the N½ of Section 19. The lease is owned by Bass entities. **Exhibit D**.
2. Federal Lease LC 067145, covering the NE¼ of Section 24-21S-28E. The lease is owned by Bass entities. **Exhibit E**.

3. Federal Lease LC 068284, covering the NE¼ of Section 24-21S-28E. The lease is owned by Bass entities. **Exhibit F.**

Royalty, overriding royalty, and working interests are common among the leases. Thus, the encroachment does not adversely affect any offset owners. As a result, notice of the application has not been given to anyone.

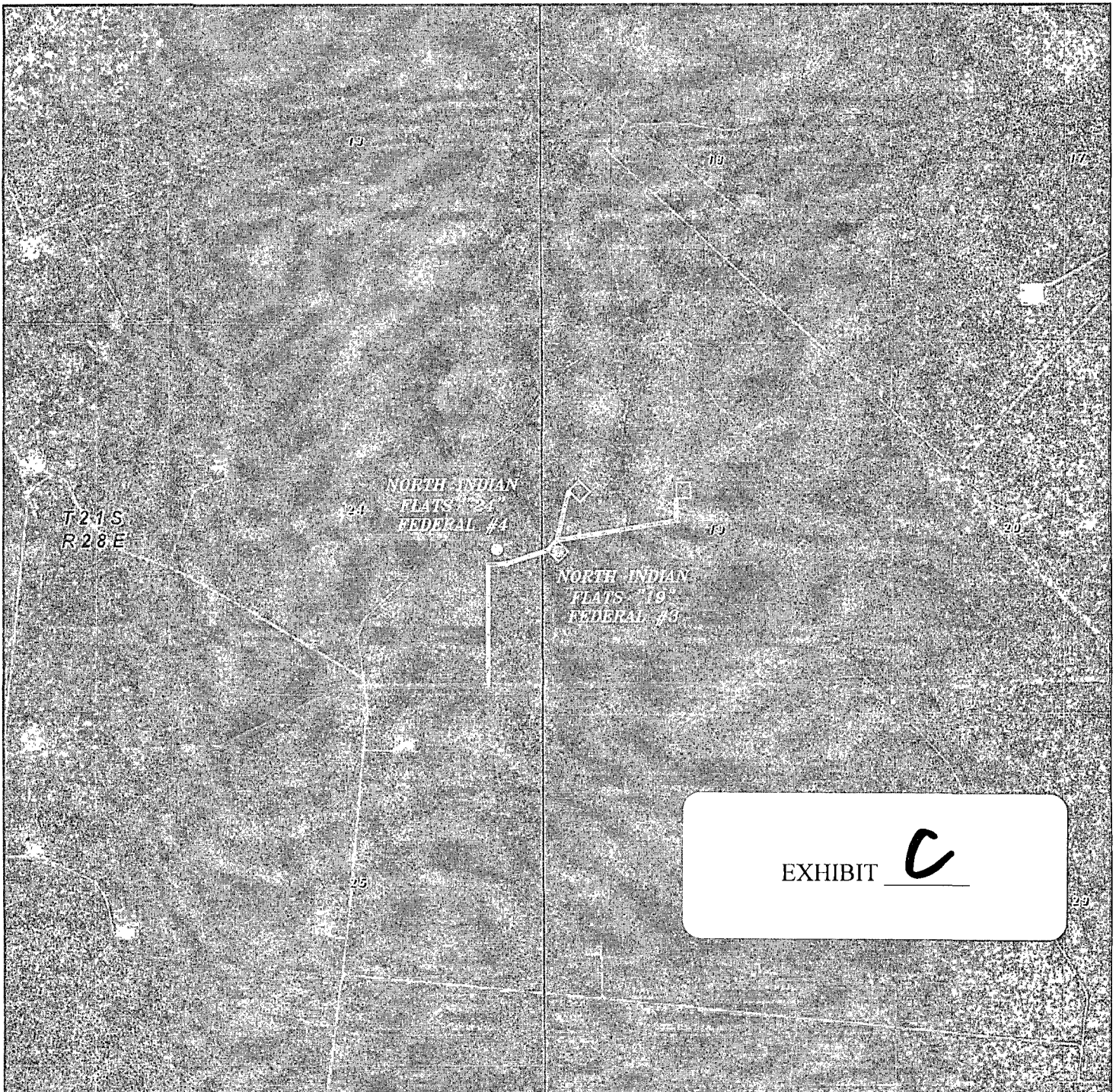
THE NORTH INDIAN FLATS "19" FEDERAL #3 LOCATED 2310'

FROM THE SOUTH LINE AND 200' FROM THE WEST LINE OF

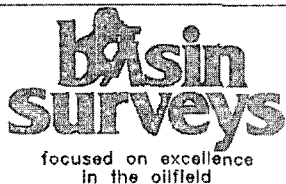
