As agent for Rice Operating Company (ROC), Trident Environmental submits this final plugging report for the above-referenced site. In accordance with your request on May 26, 2010, the drilling contractor (Harrison & Cooper, Inc.) used a cement grout with 1% to 3% bentonite and a 3 foot cap of cement at the surface to plug groundwater monitoring wells MW-1, MW-2, and MW-4, and recovery well RW-1, on June 8, 2010. A copy of the individual well plugging reports and photographic documentation of the task are attached.
