APPLICATION

Applicants, T. S. Harrigan and E. L. Harrigan, hereby apply to the Oil Conservation Commission of the State of New Mexico for approval of a non-standard gas proration unit as an exception to the pool rules of the Fulcher-Kutz Pictured Cliffs gas pool, San Juan County, New Mexico, said rules being Order No. R-565, Rule 6-A, this application being brought under the provisions of Rule 6-B as revised; said proposed unit to consist of the S $\frac{1}{2}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 19, Township 29 North, Range 11 West, N.M.P.M., as reflected by the plat attached hereto and marked Exhibit A, containing 159.47 acres, more or less.

In the support of their application, applicants would show:

1. That applicants are present owners of all operating rights in the proposed non-standard gas proration unit.
2. That heretofore applicants' predecessor drilled the No. 1 Cassady Well, located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said section in accordance with the rules and regulations then in effect, and completed the same as a commercial well productive of gas from the Pictured Cliffs formation on January 6, 1949.
3. That the proposed non-standard proration unit consists of contiguous quarter-quarter sections.

4. That the proposed non-standard gas proration unit lies wholly within Section 19, Township 29 North, Range 11 West N.M.P.M., San Juan County, New Mexico.

5. That in the opinion of the applicants the entire proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.

6. That applicants have on April 13th, 1955, notified operators owning interests in Section 19, Township 29 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, and offset operators to the No. 1 Cassady Well, of applicants' intent to form such non-standard gas proration unit and requesting waivers therefor by sending copies of this application via registered mail to the following:

7. That copies of plat reflecting well location and acreage dedicated to said well are attached hereto as a part of this application.

WHEREFORE, applicants request they be granted an order by administrative action of the commission approving a non-standard gas proration unit as applied for, or in the alternative, that this matter be set for hearing before the Commission in accordance with its rules and regulations, and for such other and further relief as may be proper.
