Gentlemen:

The M. S. B. W. Company, Robert L. Maddox operator, hereby submits its application for administrative approval of a non-standard proration unit comprising the West Half (W $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section Twenty-Eight (28), Township Thirty (30) North, Range Twelve (12) West, N.M.P.M., San Juan County, New Mexico, said proration unit being in the Fulcher-Kutz Pictured Cliffs Pool, and in support thereof states the following facts:

1. The M. S. B. W. Company Palmer No. 1 (Patented land), located 330 feet North of the South line and 1980 feet West of the East line of Section 28, Township 30 North, Range 12 West, N.M.P.M., was completed as a gas well in March, 1947, and connected to the Southern Union Gas Company line in May, 1947.

2. That the proposed non-standard gas proration unit consists of eighty (80) acres which are contiguous quarter-quarter sections.

3. That the proposed non-standard gas proration unit lies wholly within the boundary lines of Section 28, Township Thirty North, Range 12 West, N.M.P.M.

4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.

5. That by a copy of this letter of application all operators owning interests in said Section 28, in which this non-standard

proration unit is situated and which acreage is not included in said non-standard gas proration unit and in acreage off-setting the non-standard proration unit, are being notified by registered mail of this proposed non-standard gas proration unit.

6. Therefore, the M. S. B. W. Company requests that under provisions of Rule 6 (B) revised of Order No. R-565 the Secretary of the Oil Conservation Commission grant exception to Rule No. 6 (A) without notice and hearing, and approve the subject non-standard gas proration unit.


