Gentlemen:

Please correct Administrative Order NWU-72 dated May 20, 1955 to read as follows:

Reference is made to your application for approval of a 197.19-acre non-standard gas proration unit in the Aztec-Pictured Cliffs Gas Pool consisting of the following acreage:

Township 29 North, Range 9 West, NMPM  
W/2 of Section 31

It is understood that this unit is to be ascribed to your Cain Well No. 4, located 990 feet from the South line and 1480 feet from the West line of Section 31, Township 29 North, Range 9 West, NMPM, San Juan County, New Mexico.

By authority granted me under provisions of Rule 6, Section (b) of the Special Rules and Regulations for the Aztec-Pictured Cliffs Gas Pool, as set forth in Order R-565, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 197.19 acres.
