- 1. The San Juan 29-7 Unit #34 well is located 1650 feet from the South line and 990 feet from the West line of Section 4, Township 29 North, Range 7 West.
- 2. That the proposed non-standard gas proration unit consists of 316.70 acres which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.


