- The Daum #1 Well, located 660' from the South line and 660' from the West line of Section 32, Township 28 North, Range 9 West, was completed as a gas well on October 20, 1950, and connected to El Paso Natural Gas Company's gathering system on May 18, 1953.
- 2. That the proposed non-standard gas proration unit consists of <u>168.37 acres which are contiguous quarter-quarter sections</u> and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


