- 1. The Feuille #1 Well, located 1650 feet from the North line and 990 feet from the East line of Section 13, Township 29 North, Range 9 West, was completed as a gas well, December 28, 1952, and connected to El Paso Natural Gas Company's gathering system on February 25, 1953.
- That the proposed non-standard gas proration unit 2. consists of 303.92 acres which are contiguous quarterquarter sections (lots).
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said nonstandard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed nonstandard gas proration unit.


