On behalf of Lime Rock Resources Operating Company, Inc. (Lime Rock), Talon/LPE requests permission to backfill/close the excavation associated with the remediation of this release. This request is based on the confirmation sample results (previously supplied to the NMOCD). Talon proposes to install a 20-mil liner in the main excavation area, followed by backfilling with clean fill from a nearby borrow pit. Based on the analytical results, liners will not be used in the downgradient excavation areas, but the large rocks removed from the main excavation will be relocated to the areas upgradient and down-gradient of the anode bed (as rip-rap) to inhibit excessive erosion of the clean backfill in the event of heavy rainfall prior to re-vegetation. Once backfill operations are complete, the area will be seeded with an approved seed mixture. If this workplan is approved, work will proceed immediately, and a final C-141 will accompany the final closure documentation when activities are complete.
