Pubco Development, Inc., as Operator of the Pubco, et al, State No. 19 Well, hereby submits Application for Approval of a Non-Standard Proration Unit, comprising the North Half ($N\frac{1}{2}$) of Section 2, Township 30 North, Range 8 West, San Juan County, New Mexico, and in support thereof, states the following facts:

1. The Pubco, et al, State No. 19 Well, located 990 feet from the North line and 990 feet from the East line of Section 2, Township 30 North, Range 8 West, San Juan County, New Mexico, was completed as a gas well on September 18, 1955, and was connected to El Paso Natural Gas Company's gathering system on December 15, 1955.
2. That the proposed Non-Standard Gas Proration Unit consists of 328.40 acres, which are contiguous and which comprise the North Half ($N\frac{1}{2}$) of said Section 2, Township 30 North, Range 8 West, San Juan County, New Mexico.
3. That the proposed Non-Standard Gas Proration Unit lies wholly within a single Governmental Section.
4. That the proposed Non-Standard Gas Proration Unit may reasonably be presumed to be productive of gas.

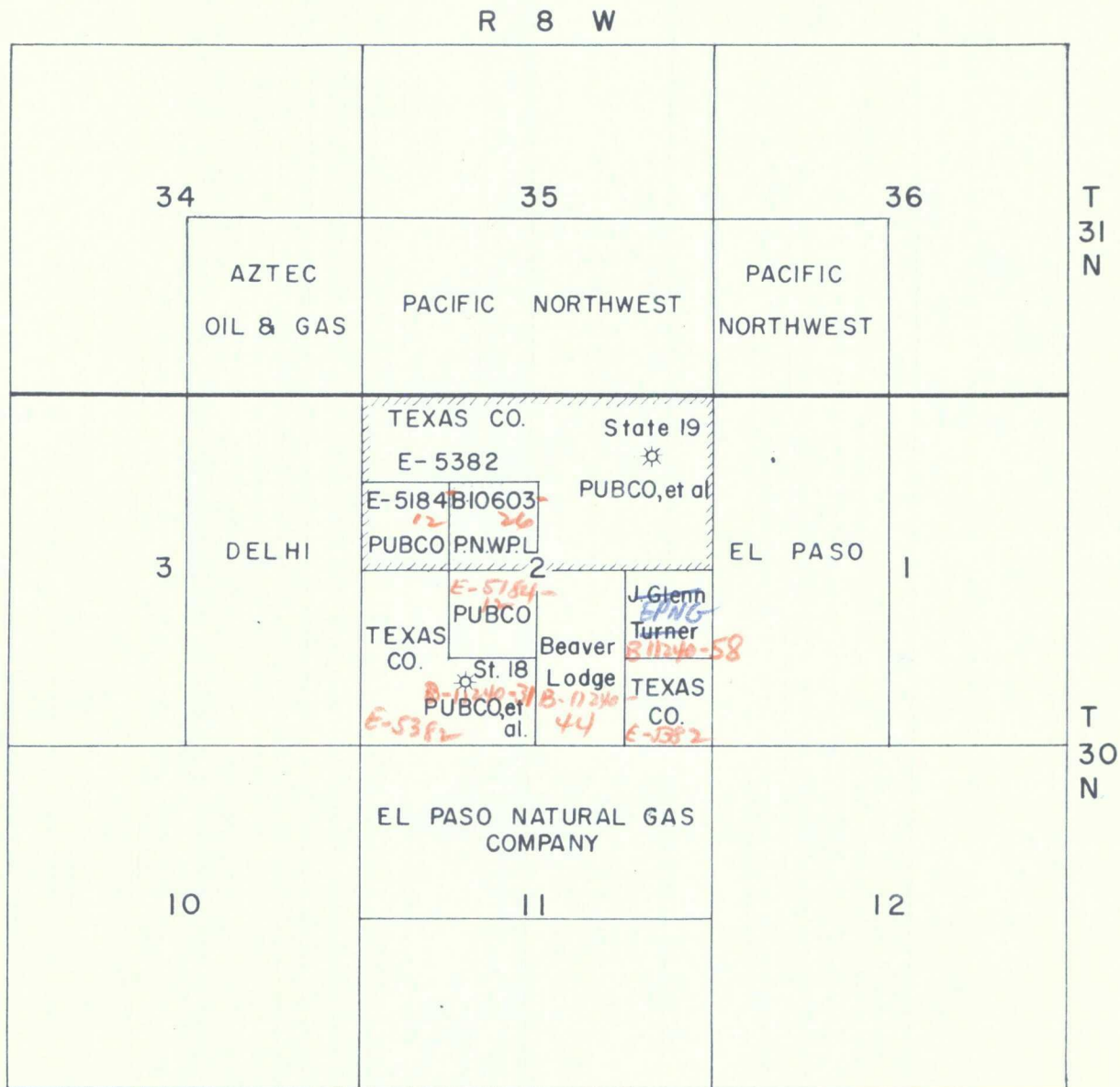
