
Ted M. White, as Unit Operator of the McMillan-White No. 1 Maddox Well, hereby submits Application for Approval of a Non-Standard Proration Unit, comprising all of Section 10, T-32-N, R-11-W, San Juan County, New Mexico, and in support thereof, states the following facts:

1. The McMillan-White No. 1 Maddox Well, located 955 Ft. from the South Line, and 1630 Ft. from the West Line of Section 10, T-32-N, R-11-W, was completed as a Gas Well on December 24, 1955, and has not been connected to a pipeline at this time.
2. That the proposed Non-Standard Gas Proration Unit consists of 335.6 acres, which are contiguous and which comprise all of said Section 10, T-32-N, R-11-W.
3. That the proposed Non-Standard Gas Proration Unit lies wholly within a single Governmental Section.
4. That the proposed Non-Standard Gas Proration Unit may reasonably be presumed to be productive of Gas.
5. That, by copies of Letters of Waiver and Written Consent, attached hereto, from all operators owning interests in the acreage off-setting the Non-Standard Proration Unit, we have obtained written consent from such owners. As stated above, the Non-Standard Proration Unit requested herewith comprises all of said Section 10, T-32-N, R-11-W, San Juan County, New Mexico.




Dear Sir:
