- 1. The Sellers #3-A Well, located 890 feet from the South line and 890 feet from the West line of Section 30, Township 30 North, Range 10 West, was dually completed as a gas well May 17, 1956 in the Mesaverde and Pictured Cliffs formations.
- 2. That the proposed non-standard gas proration unit consists of 154.60 acres which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
