Comes now J. Felix Hickman and makes application to the Commission for an exception to the provisions of Rule 6 (a) of the pool rules for the South Blanco Pictured Cliffs gas pool as contained in Order No. R-565, <sup>*Rule 6(13)-5*</sup> as amended, by administrative action as provided by Order No. R-614 for a non-standard proration unit consisting of Lots 5 and 6 and the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Six (6), Township 24 North, Range 3 West, N.M. P.M., containing 191.23 acres, more or less, according to the official governmental survey, to be dedicated to his Clark Well No. 1, and in support thereof would show:

1. That the proposed non-standard proration unit consists of more than 160 acres, the unorthodox size and shape of the tract being due to a variation of the legal subdivision of the United States Public Land Surveys.
2. The proposed non-standard proration unit consists of contiguous quarter quarter sections and lots.
3. The proposed non-standard proration unit lies wholly within a single governmental section.
4. The entire non-standard proration unit may reasonably be presumed to be productive of gas.
5. (a) All interests in the section are under common ownership and applicant has been duly designated as operator

of all lands within said section.

WHEREFORE, the applicant prays that the Commission issue its order by administrative action approving said non-standard proration unit.

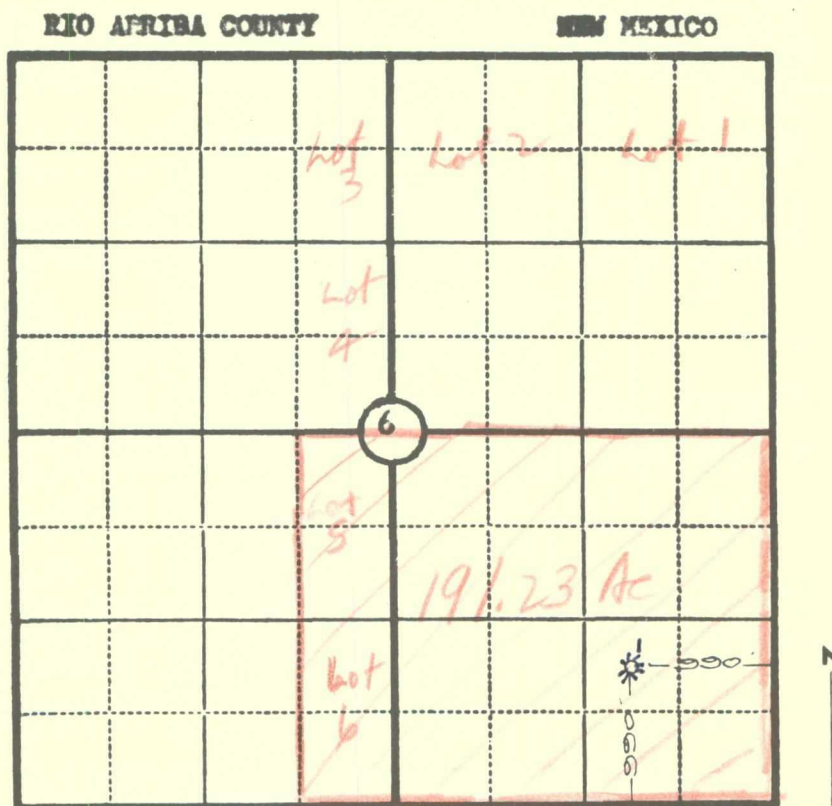


Dear Mr. Kellahin:
