Proration Unit, Blanco Mesaverde Gas Pool,  
San Juan County, New Mexico

Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the N/2 (Lots 1, 2, E/2 NW/4, NE/4) of Section 31, Township 28 North, Range 9 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Michener #5-A Well, located 1090' from the North line and 600' from the East line of Section 31, T-28-N, R-9-W, was completed as a gas well from the Mesaverde Formation on April 26, 1957.
2. That the proposed non-standard gas proration unit consists of 303.22 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.

Therefore, El Paso Natural Gas Company requests that under the provision of

Rule 1 (b) of Order No. R-128-C, the Secretary of the Commission grant exception to Rule 1(a) without Notice and Hearing and approve the subject non-standard gas production unit.



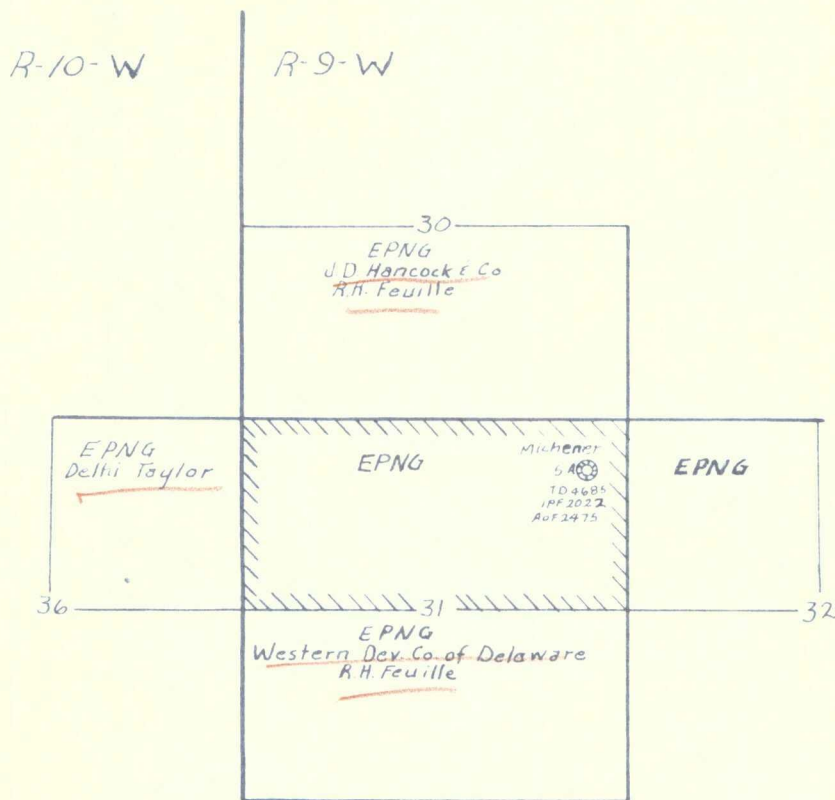
