- The Warren #2 Well, located 1460' from the South line and 1. 1750' from the West line of Section 12, T-28-N, R-9-W, was completed as a gas well from the Mesaverde Formation on August 8, 1957.
- 2. That the proposed non-standard gas proration unit consists of 269.88 acres, which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single government section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
