Dear Mr. Nutter:

I am enclosing herewith two (2) copies of plat marked "Exhibit A" reflecting the possible proration units as discussed in the letter I left with you on May 6, 1958.

Also enclosed are two (2) copies of alternate plat marked "Exhibit B" reflecting a program of possible proration units.

Please note that each plat provides for twelve (12) possible well locations and proration units. The proration units on the plat marked "Exhibit A" do not cross section lines, and while the exact locations of wells have not been surveyed on the land, it is believed by the undersigned that all locations will be orthodox.

While the proration units on the plat marked "Exhibit B" are closer to the 320 spacing limits, the proration units meander and cross section lines and have several unorthodox well locations. For this reason, El Paso Natural Gas Company favors very highly the program as discussed in my letter which was left in your office on May 6, 1958.

After my discussion with you and upon further study of the situation which exists in the San Juan 32-9 Unit, and the proration order #R-128-C. it is my belief that an administrative approval for the non-standard proration units as illustrated on "Exhibit A" would suffice for the following reasons:

1. The non-standard gas proration units consist of contiguous quarter quarter sections and/or lots.

2. The non-standard gas proration units lie wholly within single governmental sections.

3. All the non-standard gas proration units may reasonably be presumed to be productive of gas.

4. We have left in your possession copies of letters of the majority of the working interest owners within the San Juan 32-9 Unit, which included within these letters are approvals of all operators owning interest in the subject proration units.

I would appreciate, after your further consideration of this proposal, if you feel that same cannot be approved administratively, that you would advise me by telephone collect as to your feelings on this matter. If you agree that this program can be approved administratively, I will appreciate your having Mr. Porter so execute a copy of the letter which was left in your possession and return the original and all copies, after one copy is placed in your file.

I wish to thank you in advance for your expediting this approval.


