Application of Magnolia Petroleum Company  
for Approval of a Non-Standard Gas Proration  
Unit for the Jicarilla "C" 2 within the Blanco-  
Mesa Verde Gas Pool, Rio Arriba County, New  
Mexico.

Magnolia Petroleum Company herein applies for administrative ap-  
proval of a non-standard gas proration unit completed in the Blanco-  
Mesa Verde Gas Pool, Rio Arriba County, New Mexico. This well, its  
location, the attributable acreage and its description is as follows:

The unit area for this well has previously and inadvertently been  
designated as 320 acres in size on the requisite commission forms  
for its operation. It now appears this proration unit does not  
consist of the 320 acres but rather some area less than 320 acres  
as set out above by reason of its location in a non-standard govern-  
mental section.

Therefore, Magnolia seeks to correct the acreage attribution for this  
well through a request for a non-standard proration unit. Approval  
is sought under the administrative authority granted to the Secretary-  
Director under Rule 1(b) of Section 15 of the Special Rules and  
Regulations for the Blanco-Mesa Verde Gas Pool as set out in Rule 128-D.

The following facts indicate that the unit will conform to requirements of Rule 1(b):

1. The unit consists of contiguous quarter-quarter sections.
2. The unit would lie wholly within a governmental section.
3. The unit in its entirety is judged to be reasonably productive of gas.
4. All unit acreage would be within leases held only by Magnolia Petroleum Company.
5. Application for the Mesa Verde formation only.
6. Copies of this application with the request to notify the Commission of any objection have been sent by registered mail to all known offset operators.

Plats showing the acreage requested for attribution and the well location are attached and are hereby made a part of this application.

Since the requested unit would comply to requirements of Rule 1(b) of Order 128-D, and other appropriate action has been taken as required by that order, Magnolia Petroleum Company respectfully requests approval for a non-standard gas proration unit for the Jicarilla "C" 2.



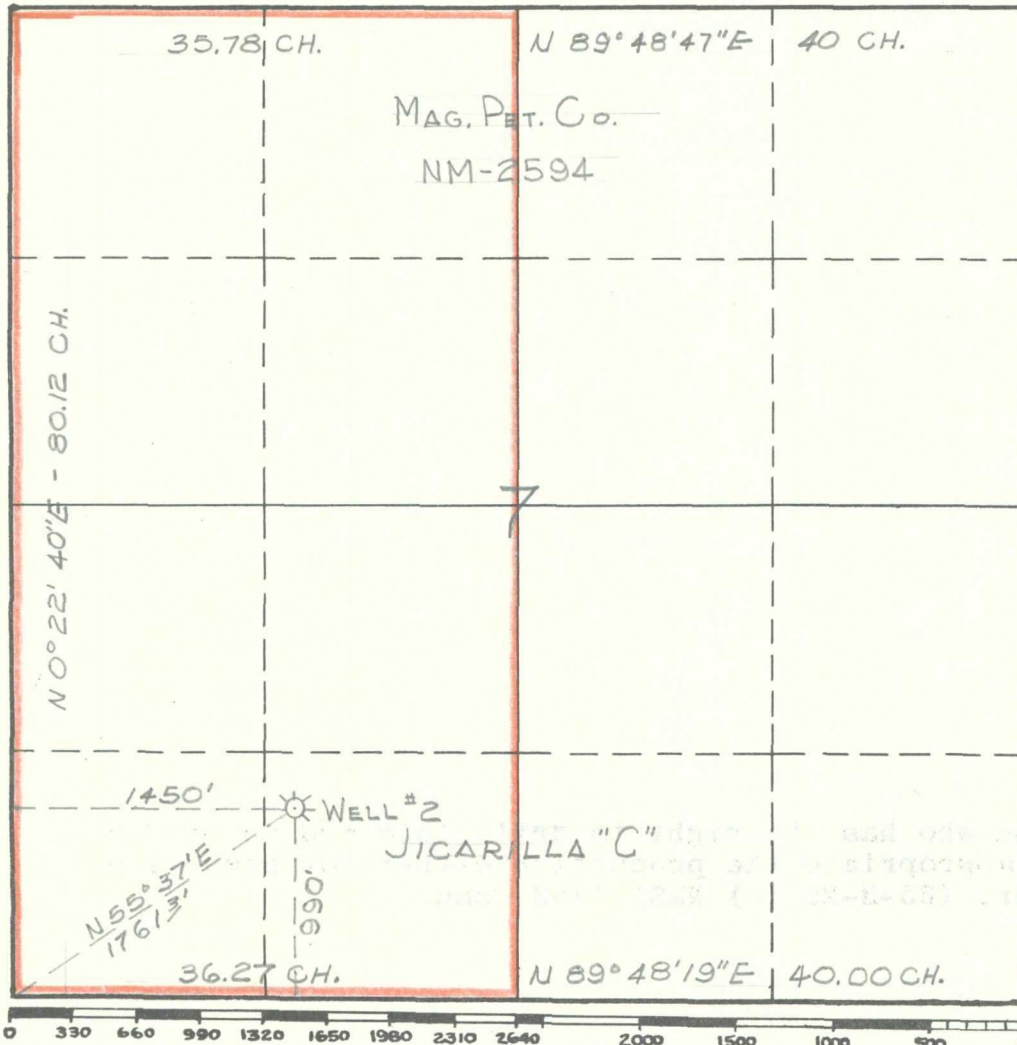
