Gentlemen:

A portion of the Shell Oil Company's Phillips #4 Lease, Section 15, Township 25 North, Range 12 West, more specifically the west half of the northwest quarter has been traded to the Phillips Petroleum Company by the Shell Oil Company. This acreage was subsequently included in the Central Bisti Unit. This caused two standard (east-west) proration units to be partially within the Unit and partially without.

In talking with Shell Oil Company it is our understanding that they will dedicate unit "C" and "F" to be a (north-south) proration unit. We wish to waive objection to their doing this. The Sunray Mid-Continent Oil Co., as operator of the Central Bisti Unit, requests administrative approval to dedicate units "D" and "E" as a (north-south) proration unit in the Central Bisti Unit.

The attached plat on commission form C-128 shows this requested change.

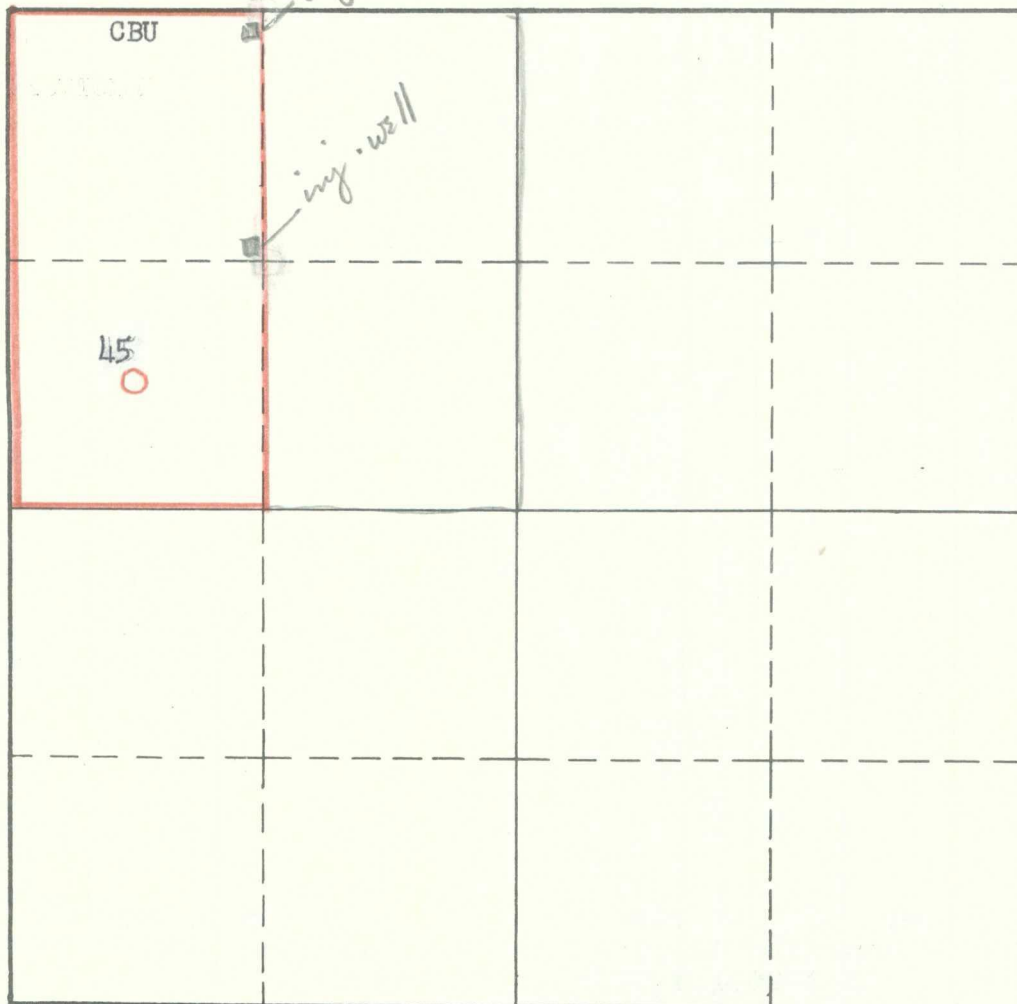
