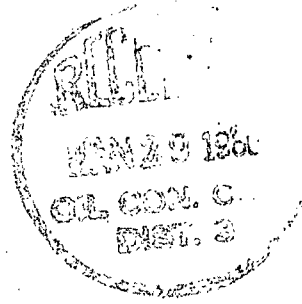
This is several acres short of a standard Dakota gas unit so, in compliance with Commission Order R-1287, offset operators are being notified of our intent to drill.

This is several acres short of a standard Dakota gas unit so, in compliance with Commission Order R-1287, offset operators are being notified of our intent to drill.

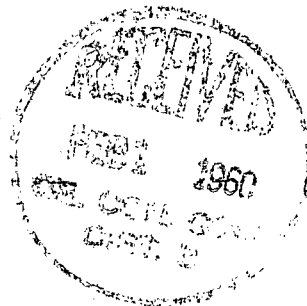

Pubco Petroleum Corporation is planning to drill a Dakota well, Pubco State No. 26, Unit N, SW $\frac{1}{4}$ Section 36, 29N-11W, 790 feet from the South line and 1650 feet from the West line. The South half of Section 36 is dedicated to the well.

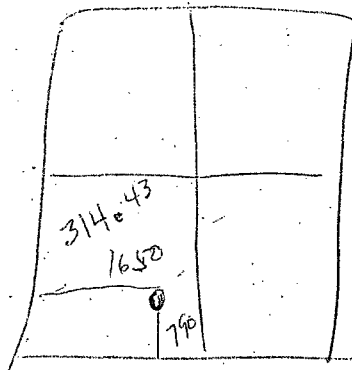
Section 36 is a "short" section and the total acreage in the South half of the section amounts to 314.43 acres. Pubco Petroleum Corporation applies for approval of a non-standard gas unit in the Dakota formation consisting of 314.43 acres, all of the South half of Section 36, 29N-11W, under Order #R-1287.

A communitization agreement is being prepared with The Texas Company on the South half of Section 36, 29N-11W. Offset operators are being notified of the intention to drill.
