
El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the northwest quarter (NW/4) or (Lots 1,2, E/2 NW/4) of Section 30, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Florance #7-C Well, located 1550' from the North line and 1180' from the West line of Section 30, Township 28 North, Range 8 West, was completed as a gas well from the Pictured Cliffs Formation on March 9, 1960.
2. That the proposed non-standard gas proration unit consists of 152.69 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That El Paso Natural Gas Company is the owner of all the interest in Section 30, Township 28 North, Range 8 West and all of the offset acreage except the E/2, Section 25, Township 28 North, Range 9 West, which is owned by Pan American Petroleum Corporation.
6. That by copy of this letter of application all operators owning interests in acreage offsetting the non-standard gas proration unit are notified by registered mail of this proposed non-standard gas proration unit.

Therefore, El Paso Natural Gas Company requests that under the provision of Rule 6(b) Revised of Order No. R-565-C, the Secretary of the Commission grant exception to Rule 6(a) without Notice and Hearing and approve the subject non-standard gas proration unit.


