XTO Energy Inc. (XTO) hereby requests administrative approval for an unorthodox location for the above referenced well. Attached for your reference are the following exhibits:

- 3. Chacra Ownership Map
- 4. Chacra Production Map
- 5. Administrative Application Checklist

At the current location of 2,400' FNL and 900' FWL, the above captioned well is at a non-standard location to the south by 420 feet, as to the current 160-acre Chacra formation spacing, being the NW/4 of Section 1 in this case. Currently, the MN Galt H #2 Dakota well is spaced on 320 acres, being the W/2 of Section 1. No other XTO wells in the quarter section are deep enough to add the Chacra formation and economics do not support drilling a new well. The MN Galt H #1E initially produced from the Chacra in this quarter section but the upper Chacra formation was never recompleted.

The non-standard location will encroach on XTO's acreage to in the SW/4 of the Section. The ownership in the Chacra formation is the same in the NW/4 as it in the SW/4 with XTO owning 75% and ConocoPhillips owning the remaining 25%. XTO is the offsetting operator in the SW/4 so no offset owner notice is required. However, ConocoPhillips will be noticed as a courtesy with the recompletion proposal.


