
Burnett has completed the final phase of the above listed site.

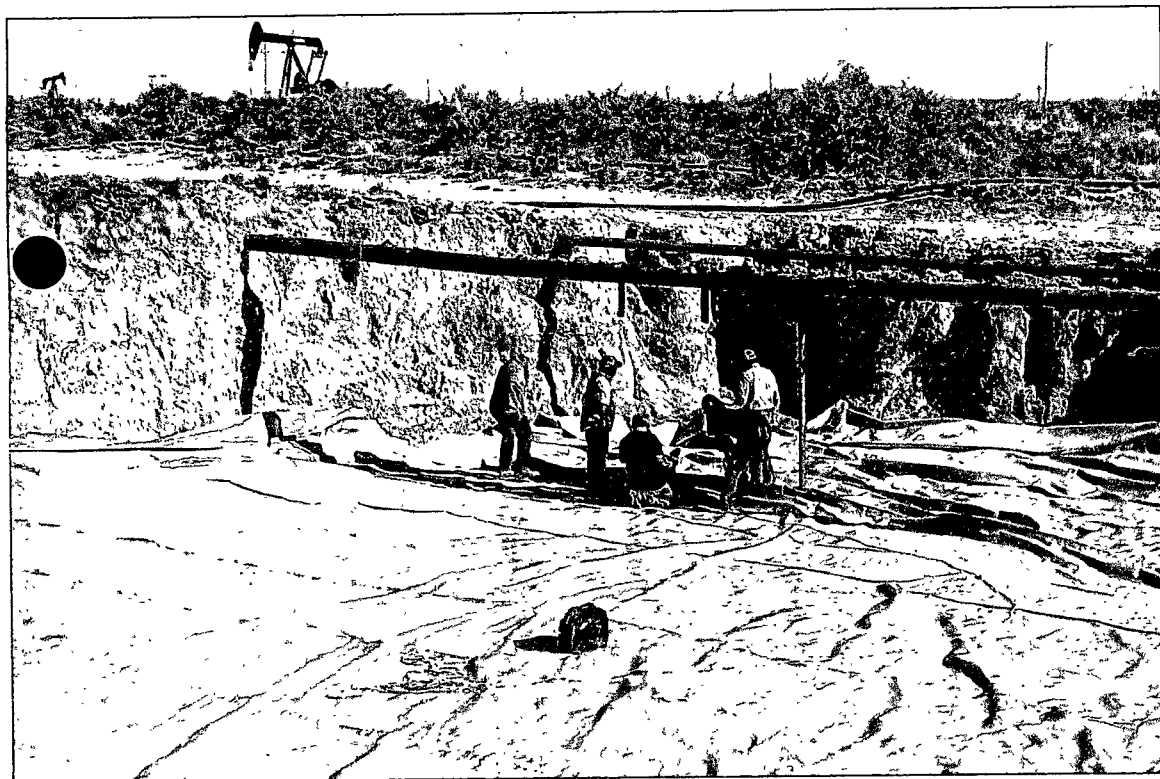

I would appreciate a letter of approval to continue with the closing.

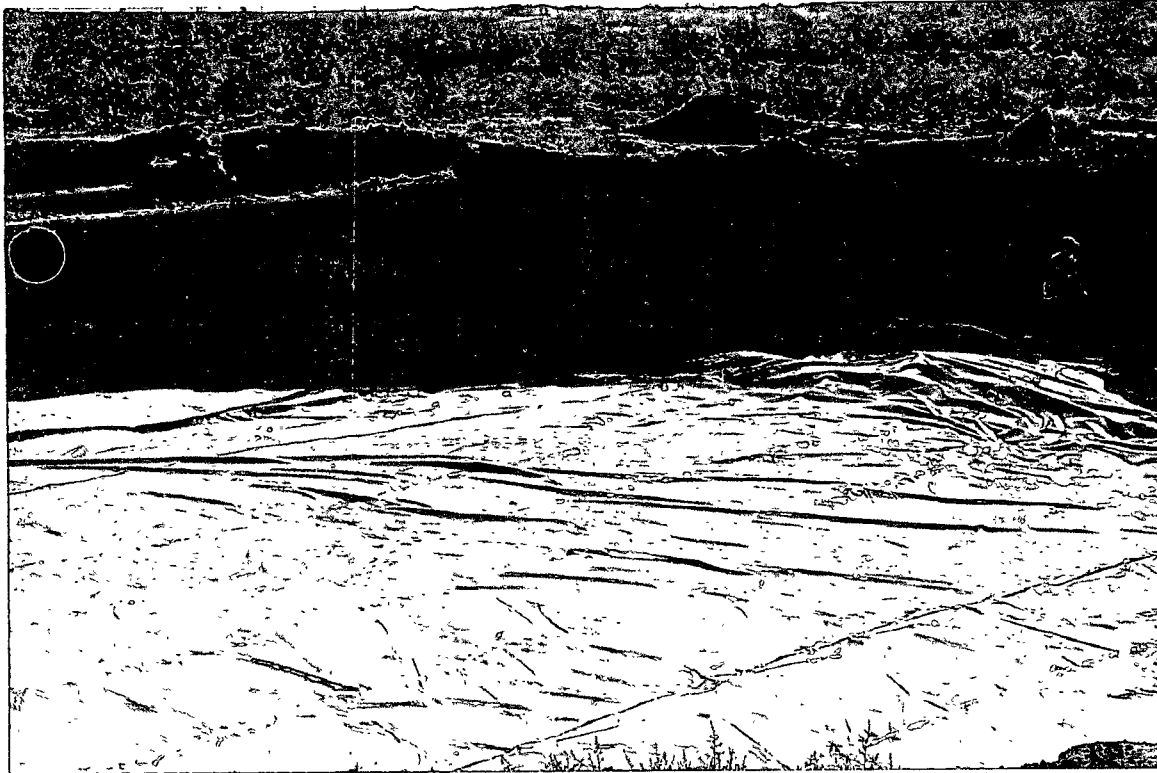
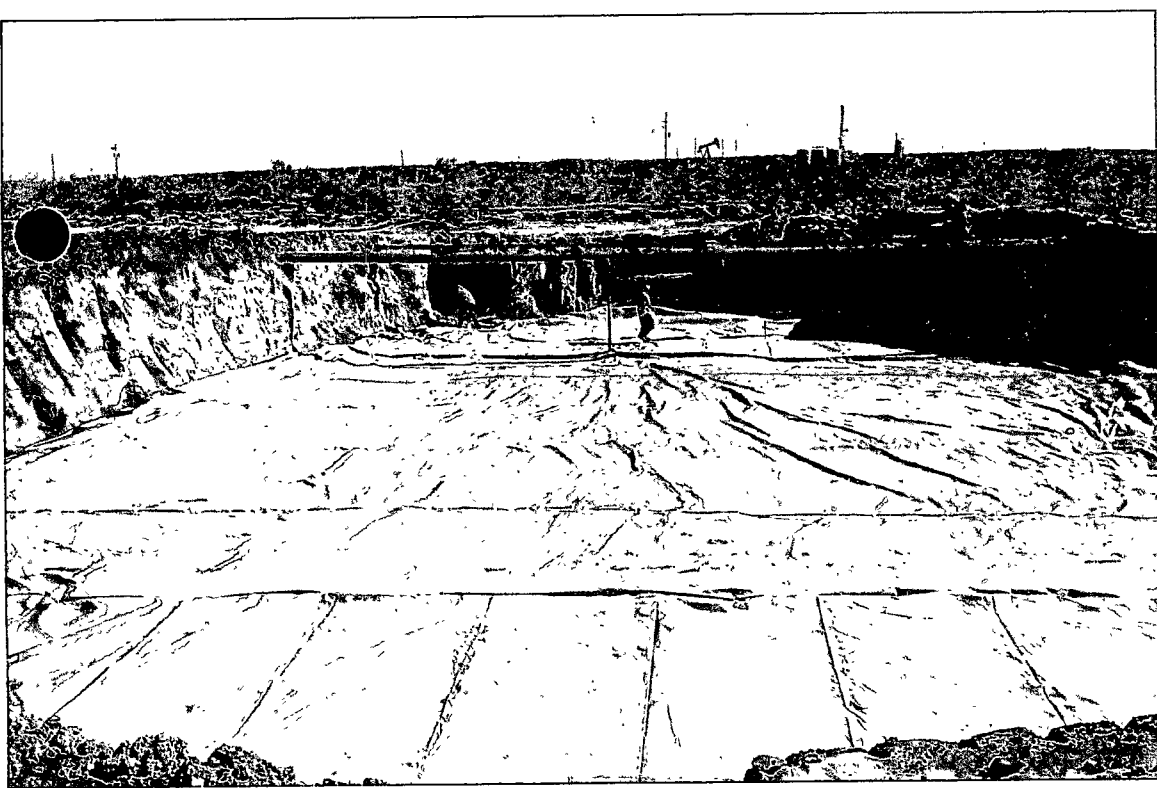
