Re: Request for Rescission of Administrative
Order NWU-397 and Application for Exception to Rule 5(A) of Order R-1670-C for a Non-Standard Proration Unit, Basin-Dakota Gas Pool, San Juan County, New Mexico

## Gentlemen:

By Administrative Order NWU-397 authority was granted to El Paso Natural Gas Company under the provisions of Order R-1670, as amended, authorizing El Paso to operate the W/2 of Section 32, Township 28 North, Range 9 West, as a Non-Standard Gas Provation Unit containing 328.37 acres.

El Paso now desires to drill a second Dakota well in Section 32, Township 28 North, Range 9 West. Because of the location terrain and resulting prohibitive cost of locating the well in the NE/4 of Section 32, El Paso desires to locate the well in the NW/4 with the N/2 of said Section 32 being dedicated thereto.

Therefore, El Paso Natural Gas Company, as Operator, respectfully requests that Administrative Order NWU-397 be—rescinded and, in accordance with Rule 5(B) of Order R-1670-C, hereby submits its application for administrative approval of the following Non-Standard Proration Unit in the Dakota Formation of the Basin-Dakota Gas Pool. The well name, description of the drilling block, and the size of the proration unit covered by this application is as follows:
