

Pursuant to Rule 1(b) of Order R-1287, Aztec Oil & Gas Company hereby submits its Application, in triplicate, for an exception to Rule 1(a) of such Order and Administrative Approval of a Non-Standard Unit consisting of the S $\frac{1}{2}$ of Section 19, T-29-N, R-11-W, N.M.P.M., San Juan County, New Mexico.

In support of this Application, Applicant respectfully states and shows the following:

1. The proposed well for this Unit has been designated Aztec's Cozzens "B" #1 and location has been staked at a point one thousand and forty-five feet (1,045') from the west line and one thousand six hundred and twenty-five feet (1,625') from the south line of Section 19.

2. Operators owning an interest in the Unit are Aztec Oil & Gas Company, Tidewater Oil Company, Redfern & Herd, Inc., and Pan American Petroleum Corporation. Operators owning acreage within Section 19 or offsetting the subject Unit are Redfern & Herd, Inc., Pan American Petroleum Corporation, Haynes & VT Drilling Co., Tidewater Oil Company, and Southern Union Gas Company. Each has been furnished a copy of this Application with a request that their consent in the form of a waiver of notice and hearing be forwarded to the Commission.

3. The non-standard unit consists of contiguous quarter-quarter sections or lots and comprises a total of 314.97 acres.

✓ 4. The non-standard unit lies wholly within a single governmental section.

✓ 5. The entire non-standard unit may reasonably be presumed to be productive of gas.

6. The length or width of the non-standard unit does not exceed five thousand two hundred and eighty feet (5,280').

Applicant respectfully requests that this Application be promptly considered and that approval be administratively granted pursuant to Rule 1(b) of Order R-1287 for the non-standard unit above described.


