

- (e) Applicant has, by registered mail, of even date herewith, furnished all offset operators with copies of this application with the request that written consent to such non-standard unit be forthwith forwarded to the Commission.

V

Applicant would respectfully show that the approval of the subject application will neither cause waste nor impair correlative rights.

Premises considered, the undersigned, as operator of the proposed non-standard unit, respectfully requests administrative approval, without notice and hearing, of an exception to the applicable provisions of the rules and regulations of the Commission in order to provide for a non-standard gas proration unit in the Basin Dakota Pool.



unitized tract covering the entire W/2 of Section 30, Town-

spectfully requests an exception to the rules of the Com-

- (e) Applicant has, by registered mail, of even date herewith, furnished all offset operators with copies of this application with the request that written consent to such non-standard unit be forthwith forwarded to the Commission.

IV

Attached hereto as Exhibit "A" is a plat of the subject non-standard unit which likewise illustrates the offsetting leases and development thereon.




