

Southern Union Production Company, herein called "Applicant," hereby makes application for an exception from the requirements of Orders R-1670 and R-1670(C) of the Rules and Regulations of the Commission, so as to authorize a nonstandard gas proration unit in the Blanco-Mesaverde Gas Pool and in the Basin-Dakota Gas Pool, and in support of such application respectfully represents and states:

1. Applicant is a corporation organized under the laws of the State of Delaware and is qualified to transact business in the State of New Mexico. Applicant's principal place of business and principal office is located at Fidelity Union Tower, 1507 Pacific, Dallas, Texas.
2. Applicant desires to form a nonstandard proration unit containing 341 acres more or less, comprised of West Half of Section 31, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico, for the production of gas in the Blanco-Mesaverde Gas Pool and Basin-Dakota Gas Pool.
3. The proposed nonstandard unit consists of contiguous quarter sections and lots as follows:




