
Therefore, El Paso Natural Gas Company requests that under the provisions of Rule 5(B) of Order R-1670-C, the Secretary of the

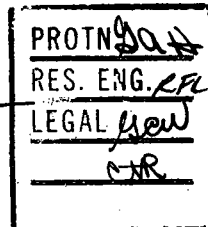
Commission grant exception to Rule 5(A) without Notice and Hearing

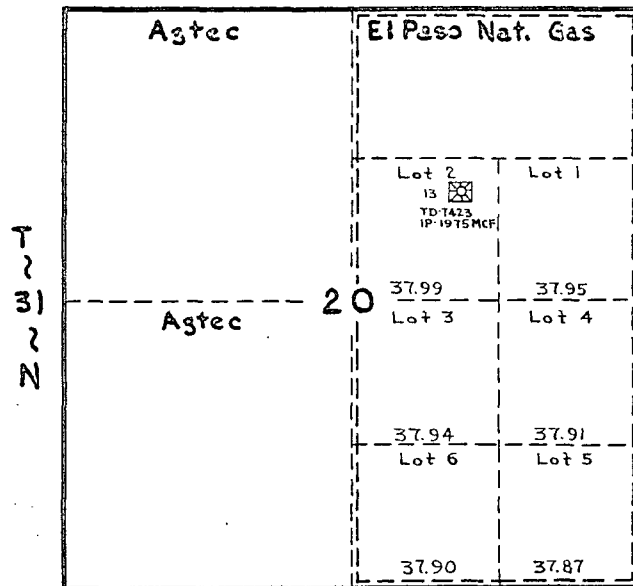
