Pursuant to Rule 5(B) of Order R-1670, Aztec Oil & Gas Company hereby submits its Application, in triplicate, for an exception to Rule 5(A) of Order R-1670, and administrative approval of a Non-Standard Gas Proration Unit consisting of Lots 3, 4, 5, 6, 8, 9, 10 and ll (W_2^1) of Section 14, T-31-N, R-12-W, N.M.P.M., San Juan County, New Mexico.

In support of this Application, Applicant respectfully states and shows the following:

1. A location has been staked seven hundred and ninety feet (790') from the north line and seven hundred and ninety feet (790') from the west line of Section 14 for the proposed well to be known as the East No. 7.

2. Applicant owns all the acreage within the Section on which the Non-Standard Unit is located, as indicated on Exhibit "A" attached hereto. The only operator owning offsetting acreage is Greenbrier Oil Company, and it has been furnished a copy of this Application with the request that its consent in the form of a waiver of notice and hearing be forwarded to the Commission.


