Pursuant to Rule 5(B) of Order R-1670, Aztec Oil & Gas Company hereby submits its Application, in triplicate, for an exception to Rule 5(A) of Order R-1670, and administrative approval of a Non-Standard Gas Proration Unit consisting of Lots 1, 2, 7, $S\frac{1}{2}NE\frac{1}{4}$, $SW\frac{1}{4}SE\frac{1}{4}$, $E\frac{1}{2}SE\frac{1}{4}$ ($E\frac{1}{2}$) of Section 14, T-31-N, R-12-W, N.M.P.M., San Juan County, New Mexico.

In support of this Application, Applicant respectfully states and shows the following:

1. A location has been staked nine hundred and ninety feet (990') from the south line and seven hundred and ninety feet (790') from the east line of Section 14 for the proposed well to be known as the Harper No. 2.

2. Applicant owns all the acreage within the Section in which the Non-Standard Gas Proration Unit is located, as indicated on Exhibit "A" attached hereto. The only operator owning offsetting acreage is Greenbrier Oil Company and it has been furnished a copy of this Application with a request that its consent in the form of a waiver of notice and hearing be forwarded to the Commission.

3. The proposed unorthorized gas proration unit contains 309.70 acres according to the United States Public Land Survey, and its un-orthodox size or shape is due to a variation in the legal subdivision thereof.

Applicant respectfully requests that this Application be promptly considered and that approval be administratively granted, pursuant to Rule 5(B) of Order R-1670, of the Non-Standard Gas Proration Unit above described.


