In accordance with Order No. R-1193, Rule 2(B), request is made for administrative approval of a non-standard gas proration unit for Northwest Production Corporation "N" Well 12-6 which is located in the NW/4 of the NW/4 of Section 6, Township 26 North, Range 4 West, Rio Arriba County, New Mexico.

The proposed non-standard unit for "N" Well 12-6 consists of Lot 3 of 40.68 acres, Lot 4 of 42.57 acres, Lot 5 of 41.75 acres, and the SE/4 NW/4 of 40.00 acres, making a total of 165.00 acres in the proration unit. The unorthodox size of the proposed unit is caused by a variation in the legal sub-division of the United States Public Land Survey, and it lies within a single governmental section, all of which is subject to an oil and gas lease in favor of Northwest Production Corporation. It is reasonable to presume that all of the non-standard unit is productive of gas.

According to our records, and as indicated on the attached plat, El Paso Natural Gas Company, P. O. Box 1492, El Paso, Texas, has an oil and gas lease covering Section 31, Township 27 North, Range 4 West; Pan American Petroleum Corporation P. O. Box 1410, Fort Worth, Texas, has an oil and gas lease covering the SE/4 Section 36, Township 27 North, Range 5 West; and Southern Union Gas Company, 1001 Burt Building, Dallas,

Texas, has an oil and gas lease covering Section 1, Township 26 North, Range 5 West. These leases offset the proposed non-standard unit and copy of this request is being furnished each of these operators by registered mail.
