

Gentlemen:

Energen Resources Corporation (Energen) hereby requests Administrative Approval for an Unorthodox Location of its San Juan 30-4 #64H Pictured Cliffs formation well under the provisions of New Mexico Oil Conservation Division, East Blanco Pictured Cliffs Pool rules.

This well is located in the SW/4 of Section 21-T30N-R4W, Rio Arriba County, New Mexico and is dedicated to a special project area consisting of the SE/4 of Section 21 and SW/4 of Section 22-T30N-R4W in the East Blanco Pictured Cliffs gas pool.

This well is located closer than 660' from the eastern special project area boundary by 557'. This well is within the boundaries of the San Juan 30-4 Unit. This location is being drilled as a horizontal well bore and is situated so that the longest lateral can be accessed. This additional length is required to provide for the potential for the production of the most reserves and the best possible economics for this well.

Attempts to drill and set casing at the legal window have been unsuccessful as a highly fractured area was encountered. This caused a substantial mud loss, hole sluffing and equipment stuck in the hole. The decision has been made to set and cement casing at a point 557' from the legal boundary and 103' from the western boundary of the special project area. Thus the wellbore will enter the Pictured Cliffs formation outside the normal setback for this formation.

Energen Resources Corporation is the operator of the affected spacing unit. There are other working interest owners who have been notified and have been requested to approve waivers. A list of these owners and copies of the waiver letters are attached to this proposal. Also attached is a well location plat showing dedicated acreage (C102) and a plat showing the affected spacing unit.

Your favorable consideration of this request is appreciated.

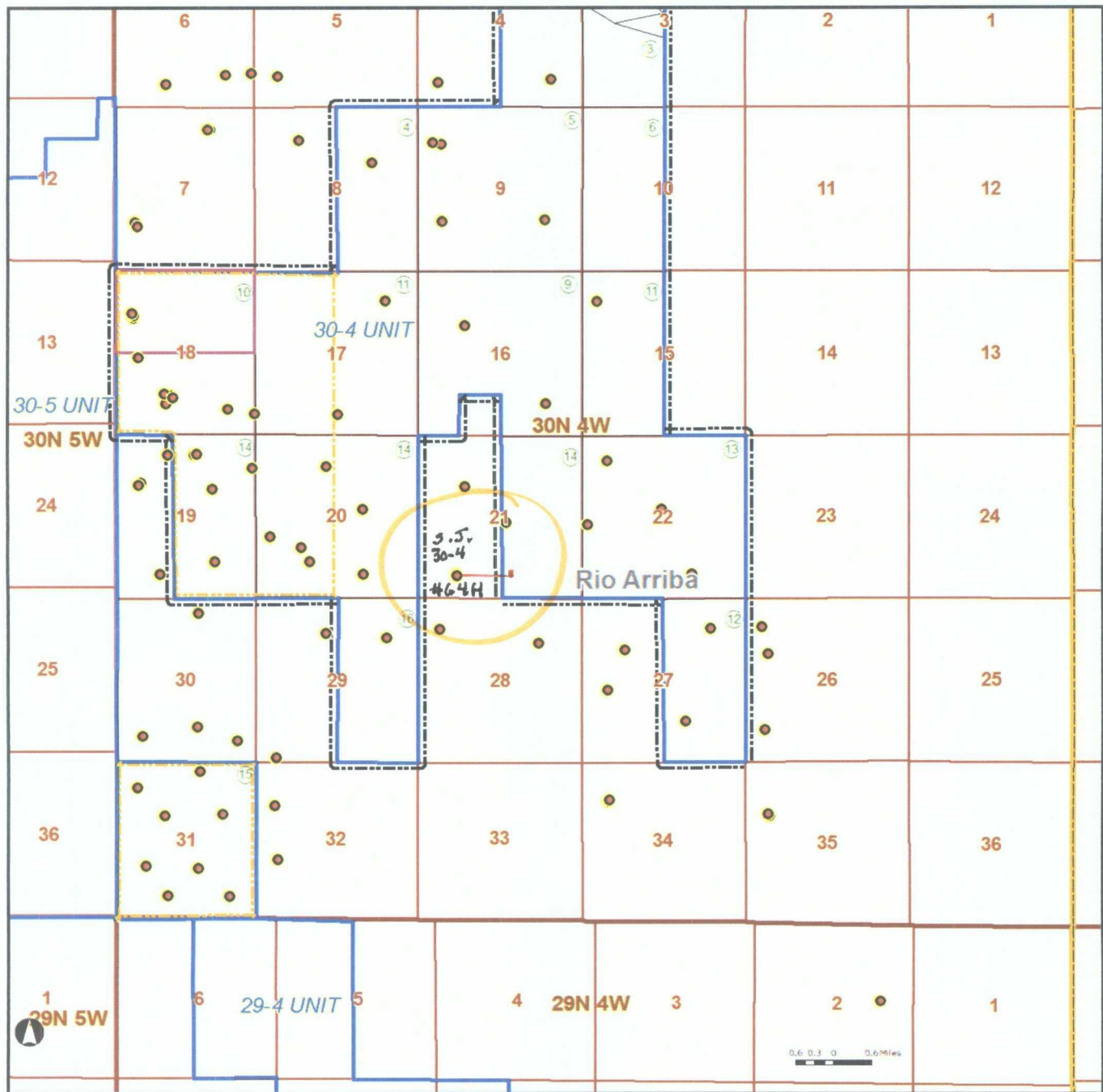
